

(MARSHILL, ALLOA) (TEMPORARY PROHIBITION OF DRIVING, PARKING AND LOADING) ORDER 2019

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restriction) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

- 1. This Order may be cited as "The Clackmannanshire Council (Marshill, Alloa) (Temporary Prohibition of Driving, Parking and Loading) Order 2019" and notwithstanding the date hereof, the Schedule shall come into operation at 0730 hours on Monday 16th September 2019 and will remain in operation for 14 days.
- 2. The effect of this Order is that there will be no driving, parking or loading at any time during:

The period from 0730 hours on Monday 16th September 2019 for a period of 14 days or until works are complete whichever is soonest, on the section of roads described in Schedule. The temporary prohibition of driving, parking and loading is necessary for resurfacing works.

The Council has made "The Clackmannanshire Council (Street, Town) (Temporary Prohibition of Driving, Parking and Loading) Order 2019, under the Road Traffic Regulation Act 1984 (as amended) on 28th August 2019: where there will be a temporary prohibition of driving, parking and loading at **Marshill, Alloa** (from its junction with Ludgate roundabout eastwards until its junction with Marshill roundabout, a distance of 190 metres or thereby). Diversion: Via B9140, A907 and vice versa. The order runs from 0730 hours on Monday 16th September 2019 for a period of 14 days or until works are complete whichever is soonest. The works are necessary for resurfacing works.
