



**(TULLIBODY ROAD, ALLOA)

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restrictions) Act 1991 and of all other powers enabling them in that behalf hereby make the following Order.

1. This Order may be cited as "The Clackmannanshire Council (Tullibody Road, Alloa) (Temporary Footway Closure) Order 2019" and notwithstanding the date hereof shall come into operation at 0930 hours on Monday 30th September 2019 and will remain in operation until 1530 hours on that day.
2. The effect of this Order shall be to close to vehicles:-
The period from 0930 hours until 1530 hours on Monday 30th September 2019, on the section described in the Schedule attached. The temporary footway closure is necessary for access a Telecoms Pole for essential upgrading.

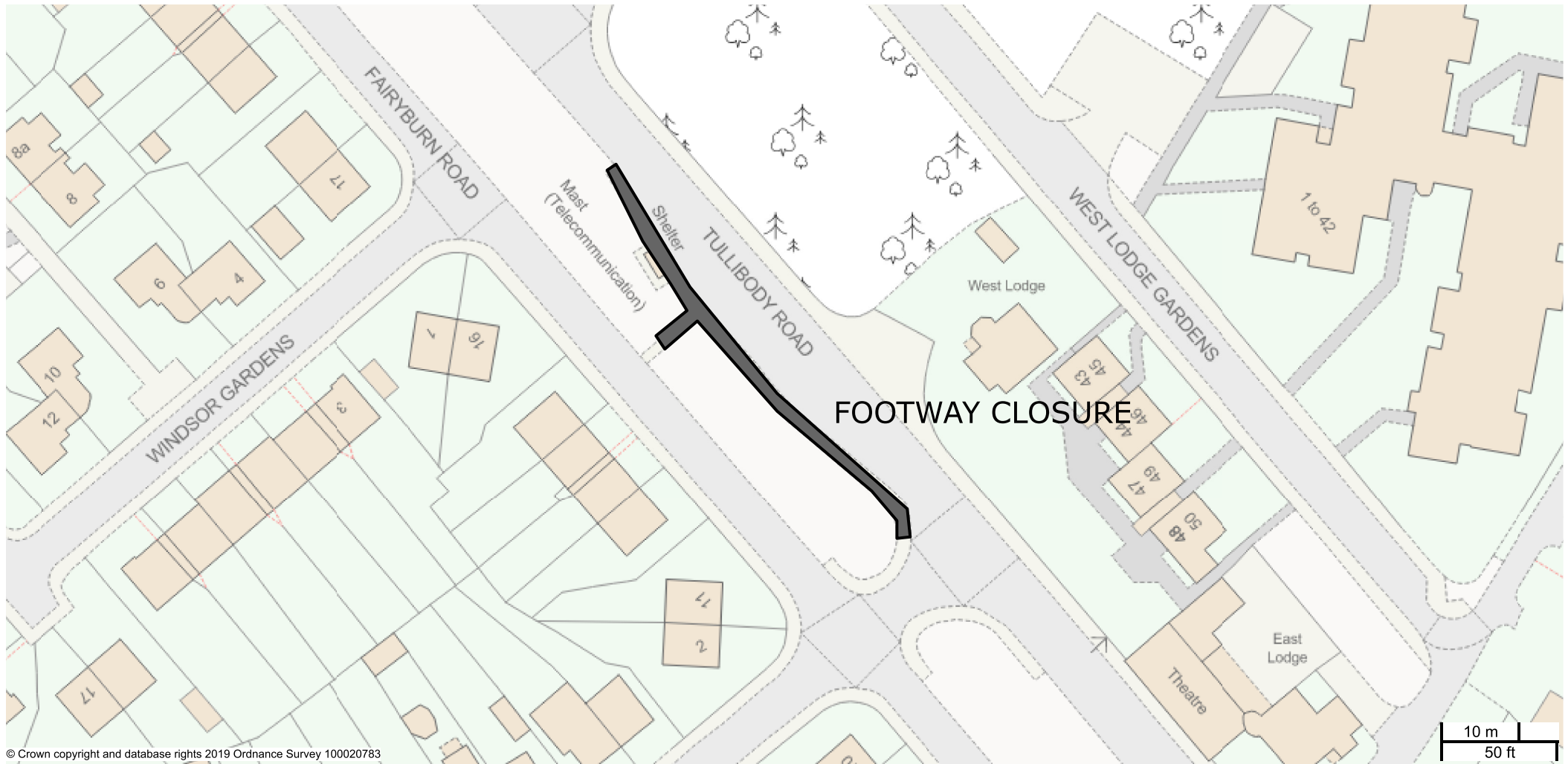
