1. This Order may be cited as "The Clackmannanshire Council (High Street, Alloa) (Temporary No Parking Restriction) Order 2019" and notwithstanding the date hereof shall come into operation at 0700 hours on Wednesday 25<sup>th</sup> September 2019 and will remain in operation for 3 days.
2. The effect of this Order shall be to suspend parking during:-  
The period from 0700 hours on Wednesday 25<sup>th</sup> September 2019 for a period of 3 days, on the section described in the Schedule attached. The temporary parking suspension is required for work vehicles during the installation of a water fountain.
