



**(THE ORCHARD, TULLIBODY)  
(TEMPORARY PROHIBITION OF DRIVING, PARKING AND LOADING) ORDER 2019**

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restriction) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

1. This Order may be cited as "The Clackmannanshire Council (The Orchard, Tullibody) (Temporary Prohibition of Driving, Parking and Loading) Order 2019" and notwithstanding the date hereof, the Schedule shall come into operation at 0800 hours on Monday 30<sup>th</sup> September 2019 and will remain in operation for a period of 9 weeks.
2. The effect of this Order is that there will be no driving, parking or loading at any time during:

The period from 0800 hours on Monday 30<sup>th</sup> September 2019 for a period of 9 weeks or until works are completed whichever is soonest, on the section of roads described in Schedule. The temporary prohibition of driving, parking and loading is necessary to allow for carriageway and footway improvement works for Tullibody South Campus. Access will be allowed for residents where possible.

Diversion: Via The Orchard, A907, B9096, Main Street, Ochil Street, Newmills and vice versa. The order runs from 0800 hours on Monday 30<sup>th</sup> September 2019 for a period of 9 weeks or until works are complete whichever is soonest. The works are necessary to allow for carriageway and footway improvement works for Tullibody South Campus. Access will be allowed for residents where possible.
