



**(PARK STREET, TILlicOUNTRY)
(TEMPORARY PROHIBITION OF DRIVING, PARKING AND LOADING) ORDER 2019**

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restriction) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

1. This Order may be cited as "The Clackmannanshire Council (Park Street, Tillicoultry) (Temporary Prohibition of Driving, Parking and Loading) Order 2019" and notwithstanding the date hereof, the Schedule shall come into operation at 0930 hours on Sunday 20th October 2019 and will remain in operation until 1530 hours on that day.
2. The effect of this Order is that there will be no driving, parking or loading at any time during:

The period from 0930 hours until 1530 hours on Sunday 20th October 2019, on the section of roads described in Schedule. The temporary prohibition of driving, parking and loading is to repair damaged iron works in the centre of the road.

The Council has made "The Clackmannanshire Council (Park Street, Tillicoultry) (Temporary Prohibition of Driving, Parking and Loading) Order 2019, under the Road Traffic Regulation Act 1984 (as amended) on 24th September 2019: where there will be a temporary prohibition of driving, parking and loading at **Park Street, Tillicoultry** (from a point 115 metres or thereby south of its junction with A91 High Street southwards for a distance of 60 metres or thereby.) The order runs from 0930 hours until 1530 hours on Sunday 20th October 2019. The works are to repair damaged iron works in the centre of the road. 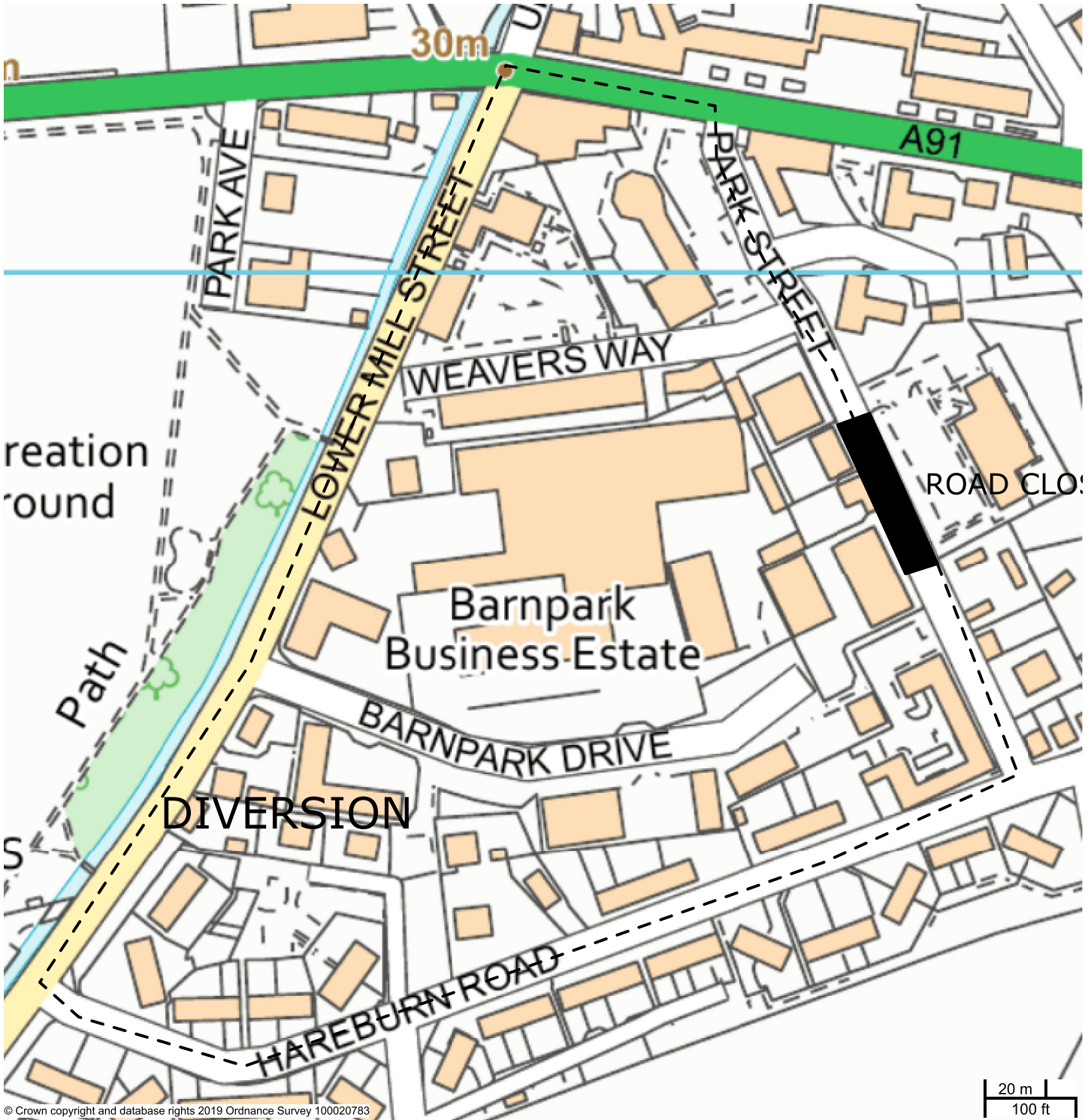
