

(A907 STIRLING ROAD, ALLOA) (TEMPORARY NO WAITING OR LOADING RESTRICTION) ORDER 2019

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restriction) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

- 1. This Order may be cited as "The Clackmannanshire Council (A907 Stirling Road, Alloa) (Temporary No Waiting or Loading Restriction) Order 2019" and notwithstanding the date hereof, Schedule shall come into operation from 1600 hours until 2100 hours on Saturday 9th November 2019. Should the event be cancelled due to adverse weather conditions on Saturday 9th November 2019, the order shall again come into operation from 1600 hours until 2100 hours on Sunday 10th November 2019.
- 2. The effect of this Order shall be that there will be no waiting at any time during:-

The period from 1600 hours until 2100 hours on Saturday 9th November 2019 (or from 1600 hours until 2100 hours on Sunday 10th November 2019 should the event be cancelled due to adverse weather conditions), on the section of roads described in Schedule. The temporary no waiting or loading is necessary for public safety during Fireworks Display. Access will be maintained for residents via Grant Street, emergency services via Ludgate and pedestrians.
