



**(VARIOUS STREETS, SAUCHIE)
(TEMPORARY PROHIBITION OF DRIVING, PARKING AND LOADING) ORDER 2019**

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restriction) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

1. This Order may be cited as "The Clackmannanshire Council (Various Streets, Sauchie) (Temporary Prohibition of Driving, Parking and Loading) Order 2019" and notwithstanding the date hereof, the Schedule shall come into operation at 1235 hours on Sunday 10th November 2019 and will remain in operation until 1335 hours on that day.
2. The effect of this Order is that there will be no driving, parking or loading at any time during:

The period from 1235 hours until 1335 hours on Sunday 10th November 2019, on the section of roads described in Schedule. The temporary prohibition of driving, parking and loading is required to facilitate the Armistice Ceremony.

The Clackmannanshire Council (Various Streets, Sauchie) (Temporary Prohibition of Driving, Parking and Loading) Order 2019

The Council has made "The Clackmannanshire Council (Various Streets, Sauchie) (Temporary Prohibition of Driving, Parking and Loading) Order 2019, under the Road Traffic Regulation Act 1984 (as amended) on 3rd October 2019: where there will be a temporary prohibition of driving, parking and loading at **Mar Place, Sauchie** (from its junction with Main Street to its junction with B908 – Alternative Route: Via Holton Crescent and vice versa), **Parkhead Road, Sauchie** (from its junction with the A908 to its junction with the B908 – Alternative Route: Via Main Street and Holton Crescent and vice versa). The order runs from 1235 hours until 1335 hours on Sunday 10th November 2019. The works are required to facilitate the Armistice Ceremony. 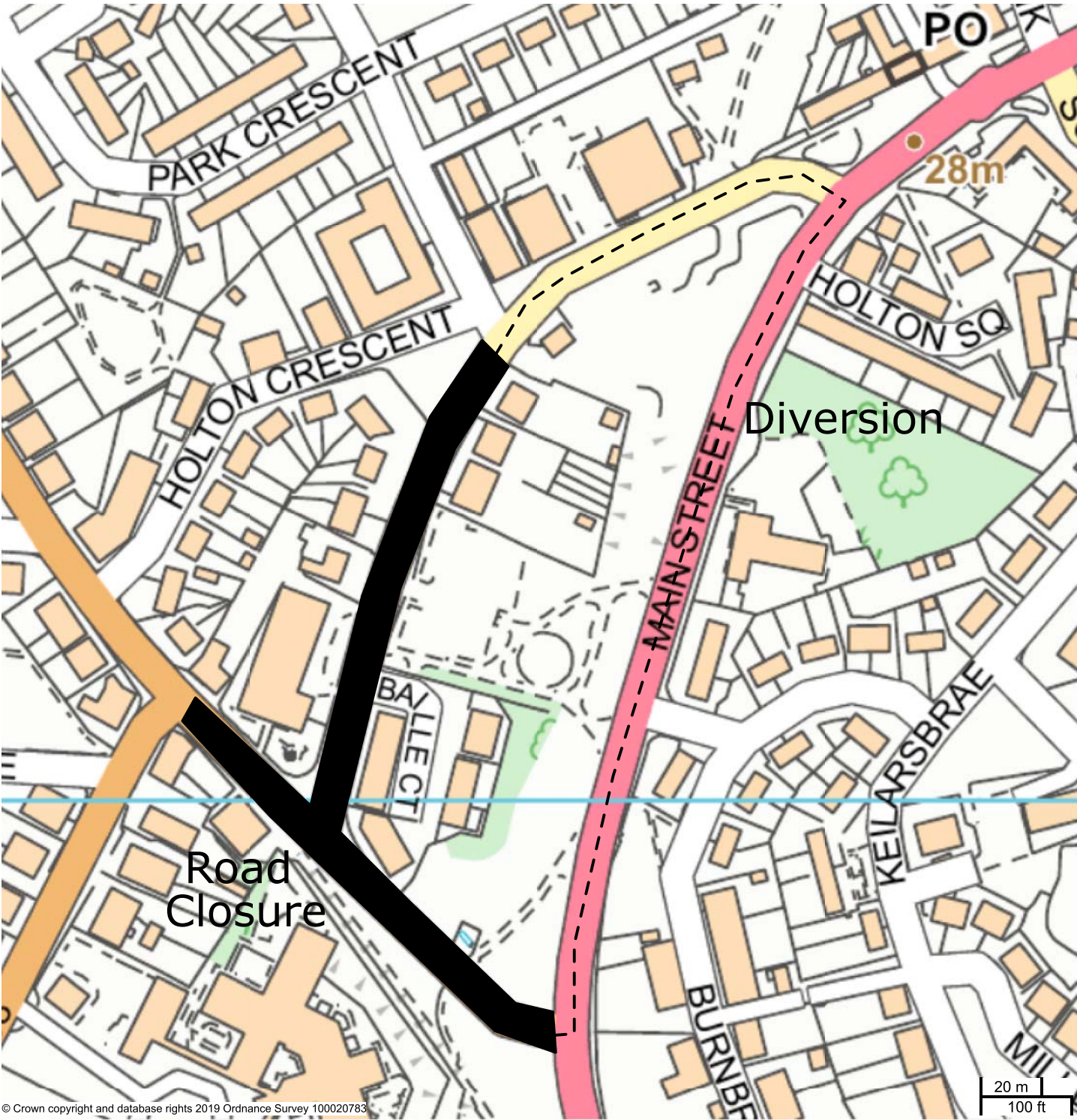
