



**(VARIOUS STREETS, ALVA)
(TEMPORARY ROLLING ROAD CLOSURE) ORDER 2019**

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restrictions) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

1. This Order may be cited as "The Clackmannanshire Council (Various Streets, Alva) (Temporary Rolling Road Closure) Order 2019" and notwithstanding the date hereof, Schedule shall come into operation at 1145 hours on Sunday 10th November 2019 and will remain in operation until 1205 hours on that day.
2. The effect of this Order shall be to close to vehicles:-

During the period from 1145 hours until 1205 hours on Sunday 10th November 2019, on the section of roads described in Schedule. The temporary closure is required to assist Police Scotland in their powers to hold traffic for the Alva Remembrance Parade.

The Council has made "The Clackmannanshire Council (Various Streets, Alva) (Temporary Rolling Road Closure) Order 2019, under the Road Traffic Regulation Act 1984 (as amended) on 7th October 2019: to close to vehicles the section of road at **A91 Stirling Street, Alva** (from a point outside Alva Parish Church westwards until its junction with Copland Place, a distance of 210 metres or thereby), **Copland Place, Alva** (for its entirety, a distance of 72 metres or thereby). The order runs from 1145 hours until 1205 hours on Sunday 10th November 2019 and is required to assist Police Scotland in their powers to hold traffic for the Alva Remembrance Parade. 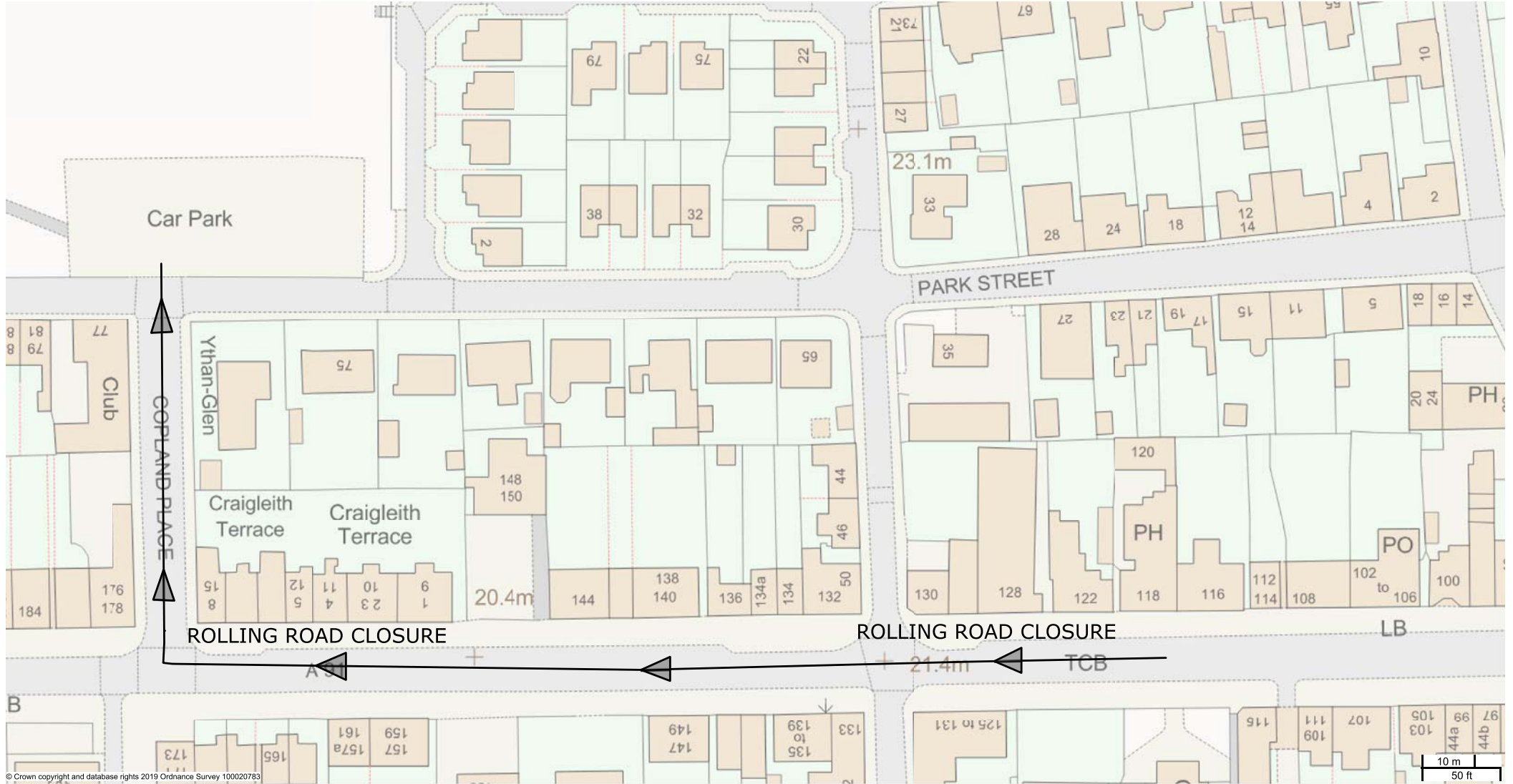
