



**(MARSHILL, ALLOA)
(TEMPORARY ROAD CLOSURE) ORDER 2019**

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restrictions) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

1. This Order may be cited as "The Clackmannanshire Council (Marshall, Alloa) (Temporary Road Closure) Order 2019" and notwithstanding the date hereof, Schedule shall come into operation at 2130 hours on Thursday 12th December 2019 and will remain in operation until 2330 hours on that day.
2. The effect of this Order shall be to close to vehicles:-

During the period from 2130 hours until 2330 hours on Thursday 12th December 2019, on the section of roads described in Schedule. The temporary closure is required for UK Parliamentary General Election, to allow staff to off-load ballot boxes at the main door of the Town Hall. Access for Earl of Mar Court residents via Marshall and staff dropping off ballot boxes is via Ludgate only.

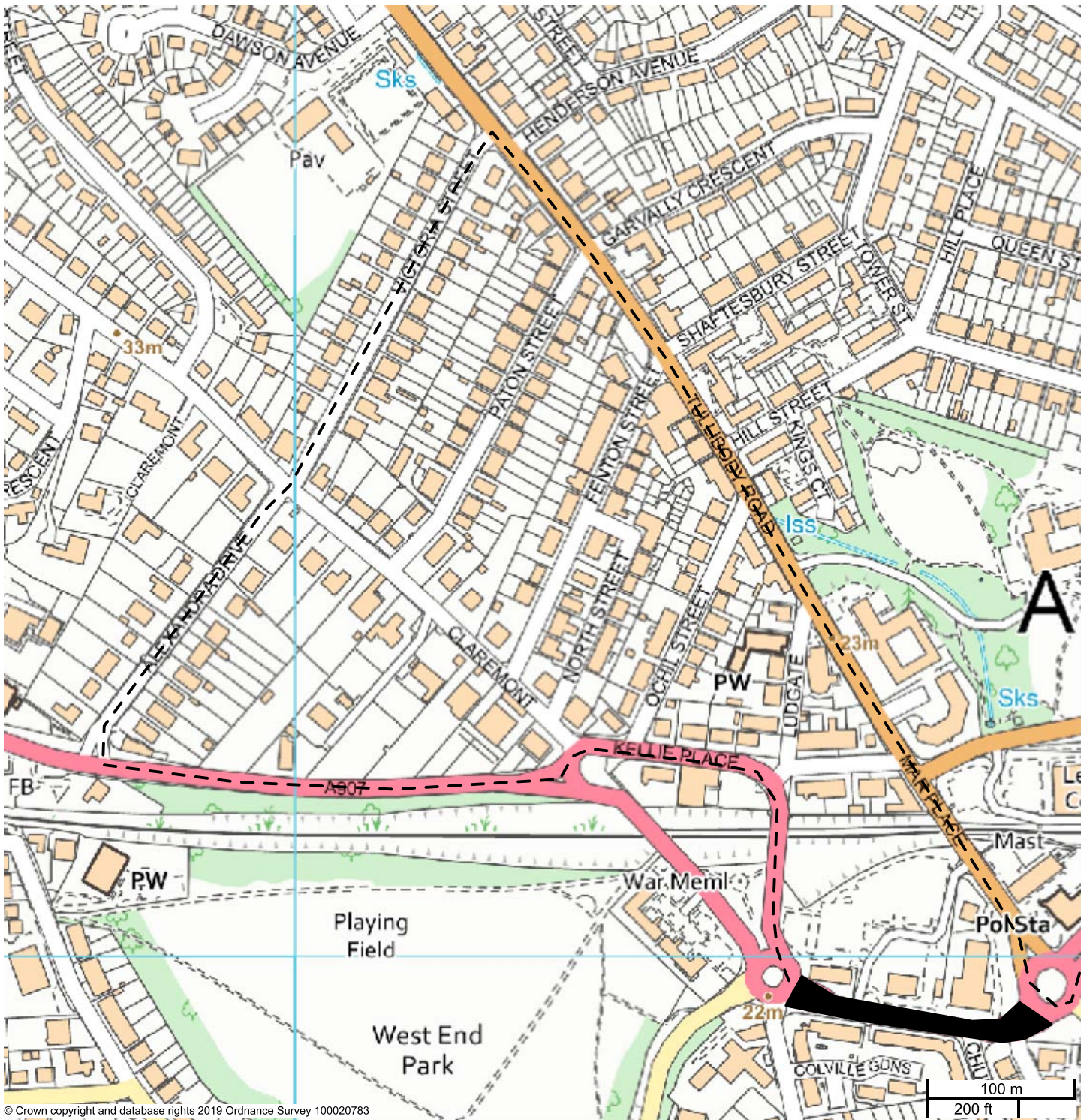
