The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restrictions) Act 1991 and of all other powers enabling them in that behalf hereby make the following Order.

1. This Order may be cited as "The Clackmannanshire Council (Link Footpath at Park Primary School, Alloa) (Temporary Footpath Closure) Order 2019" and notwithstanding the date hereof shall come into operation at 0800 hours on Monday 6<sup>th</sup> January 2020 and will remain in operation for a period of 9 months.
2. The effect of this Order shall be to close to vehicles:-  
The period from 0800 hours on Monday 6<sup>th</sup> January 2020 for a period of 9 months, on the section described in the Schedule attached. The temporary footpath closure is required for safety reasons while works are carried out at Park Primary School.

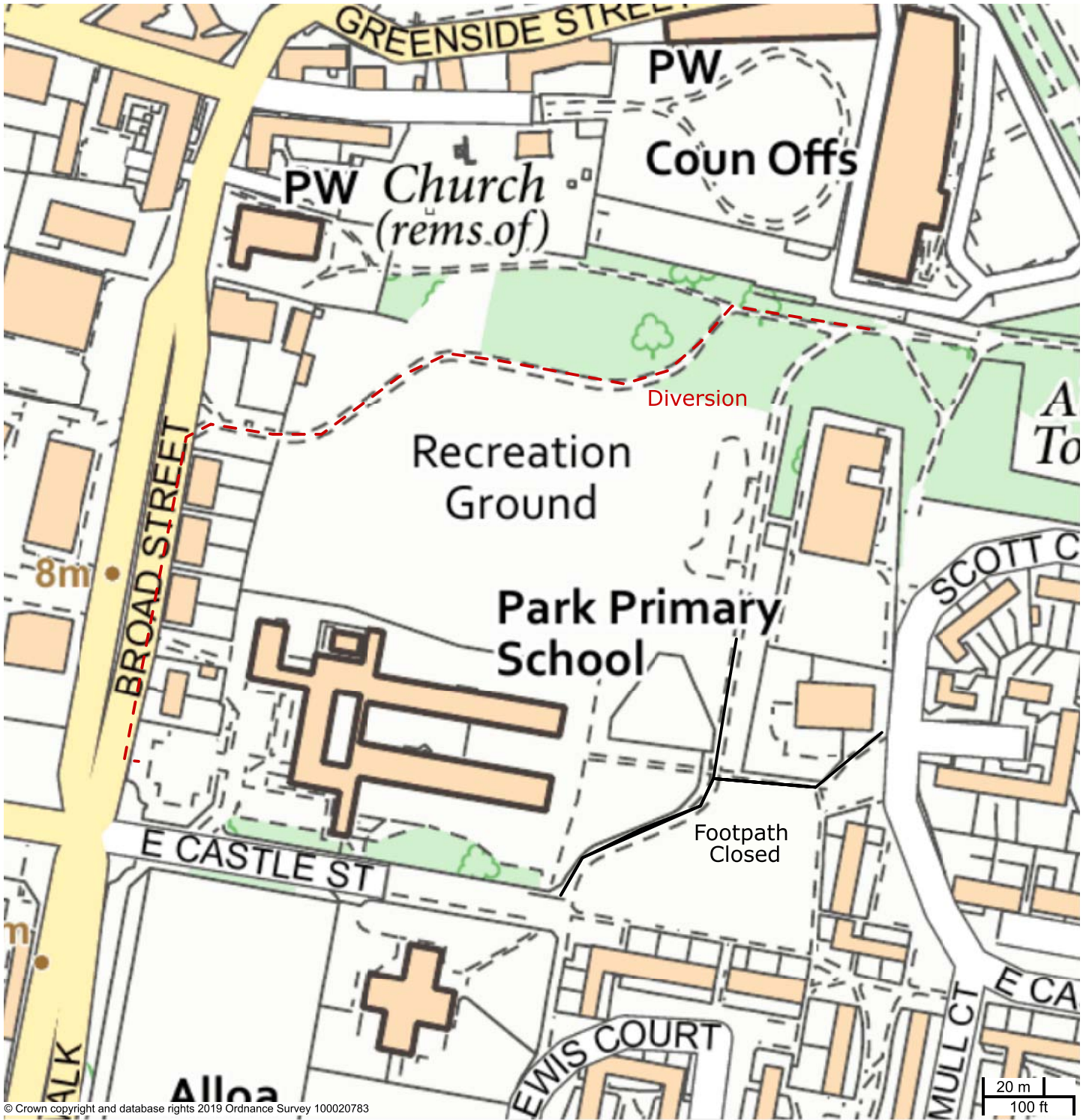
