

(VARIOUS STREETS, ALLOA) (TEMPORARY PROHIBITION OF DRIVING, PARKING AND LOADING) ORDER 2020

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restriction) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

- 1. This Order may be cited as "The Clackmannanshire Council (Various Streets, Alloa) (Temporary Prohibition of Driving, Parking and Loading) Order 2020" and notwithstanding the date hereof, the Schedule shall come into operation at 0800 hours on Sunday 1st and Sunday 8th March 2020 and will remain in operation until 1800 hours on both dates.
- 2. The effect of this Order is that there will be no driving, parking or loading at any time during:

The period from 0800 hours until 1800 hours on Sunday 1st and Sunday 8th March 2020, on the section of roads described in Schedule. The temporary prohibition of driving, parking and loading is necessary to allow BT works to take place. Access will be maintained where possible for residents and businesses.

The Council has made "The Clackmannanshire Council (Various Streets, Alloa) (Temporary Prohibition of Driving, Parking and Loading) Order 2020, under the Road Traffic Regulation Act 1984 (as amended) on 3rd February 2020: where there will be a temporary prohibition of driving, parking and loading at **Drysdale Street** (from its junction with Marshill roundabout eastwards until its junction with Primrose Street, a distance of 125 metres or thereby. <u>Diversion</u>: Via King Street, Primrose Street). **Mar Street** (from its junction with Mill Street northwards until its junction with Marshill roundabout, a distance of 240 metres or thereby. <u>Diversion</u>: Via Burgh Mews). The order runs from 0800 hours until 1800 hours on Sunday 1st and Sunday 8th March 2020. The works are necessary to allow BT works to take place. Access will be maintained where possible for residents and businesses.
