



**(VARIOUS STREETS, ALLOA)
(TEMPORARY REVOCATION OF ONE WAY) ORDER 2020**

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restrictions) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

1. This Order may be cited as "The Clackmannanshire Council (Various Streets, Alloa) (Temporary Revocation of One Way) Order 2020" and notwithstanding the date hereof shall come into operation at 0800 hours on Sunday 1st and Sunday 8th March 2020 and will remain in operation until 1800 hours on that day.
2. The effect of this Order shall be to suspend one way traffic during:-

The period from 0800 hours until 1800 hours on Sunday 1st and Sunday 8th March 2020. The temporary one way suspension is required to allow access to Primrose Street from Drysdale Street due to the temporary Closure of A907 Ring Road.

The Council has made "The Clackmannanshire Council (Various Streets, Alloa) (Temporary Revocation of One Way) Order 2020, under the Road Traffic Regulation Act 1984 (as amended) on 3rd February 2020: to suspend one way traffic at **Mill Street, Alloa** – (from its junction with High Street south westwards until its junction with Mar Street, a distance of 32 metres or thereby), **Mar Street, Alloa** – (for its entirety, a distance of 238 metres or thereby). The order runs from 0800 hours until 1800 hours on Sunday 1st and Sunday 8th March 2020 and is required to allow access to Primrose Street from Drysdale Street due to the temporary closure of A907 Ring Road. 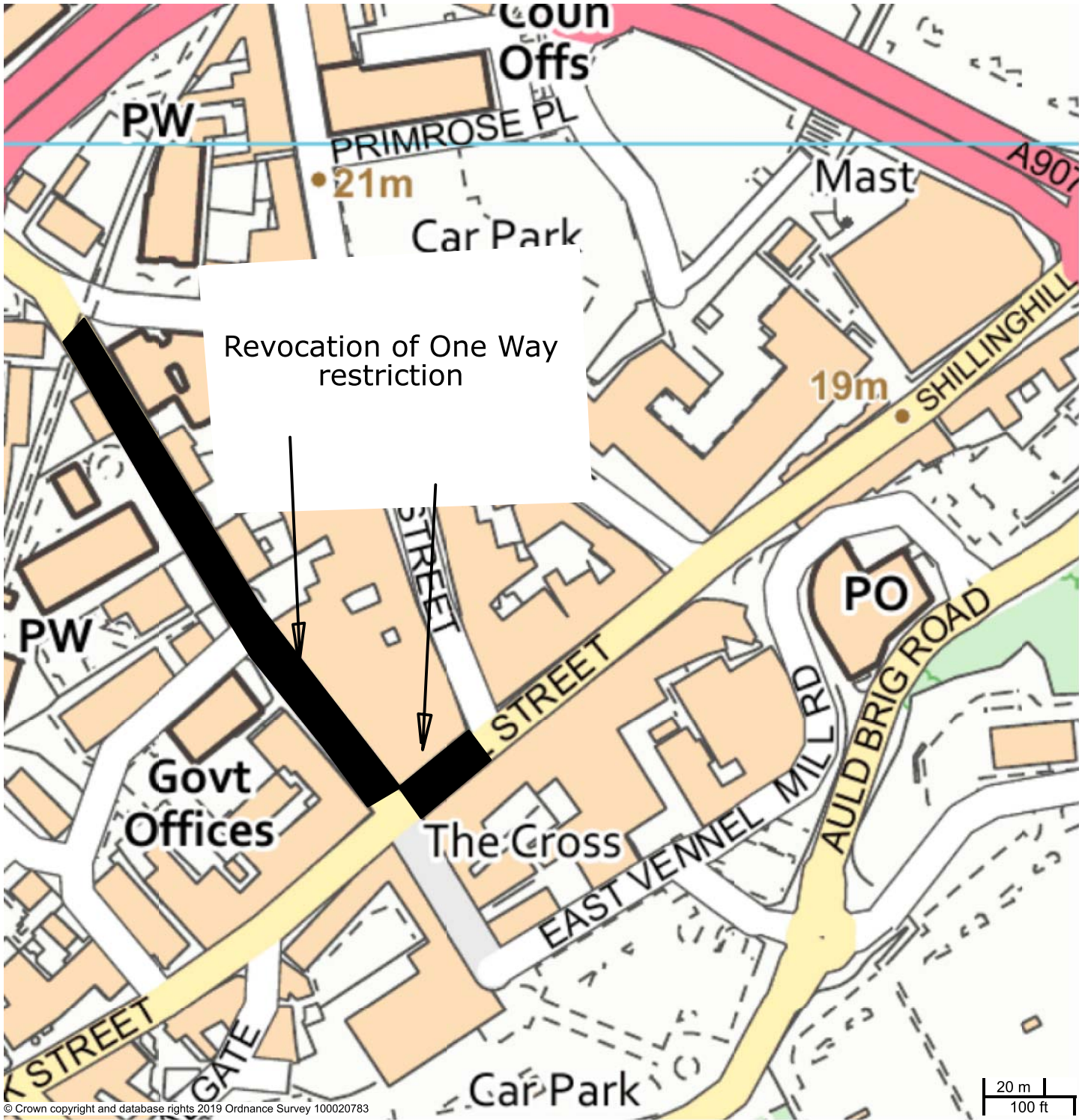
