



**(B910 CLACKMANNAN TO FORESTMILL)  
(TEMPORARY PROHIBITION OF DRIVING, PARKING AND LOADING) ORDER 2020**

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restriction) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

1. This Order may be cited as "The Clackmannanshire Council (B910 Clackmannan to Forestmill) (Temporary Prohibition of Driving, Parking and Loading) Order 2020" and notwithstanding the date hereof, the Schedule shall come into operation at 0700 hours on Wednesday 18<sup>th</sup> March 2020 and will remain in operation until 1700 hours on Saturday 28<sup>th</sup> March 2020.
2. The effect of this Order is that there will be no driving, parking or loading at any time during:

The period from 0700 hours on Wednesday 18<sup>th</sup> March 2020 until 1700 hours on Saturday 28<sup>th</sup> March 2020, on the section of roads described in Schedule. The temporary prohibition of driving, parking and loading is necessary to allow works to take place on behalf of Scottish Power.

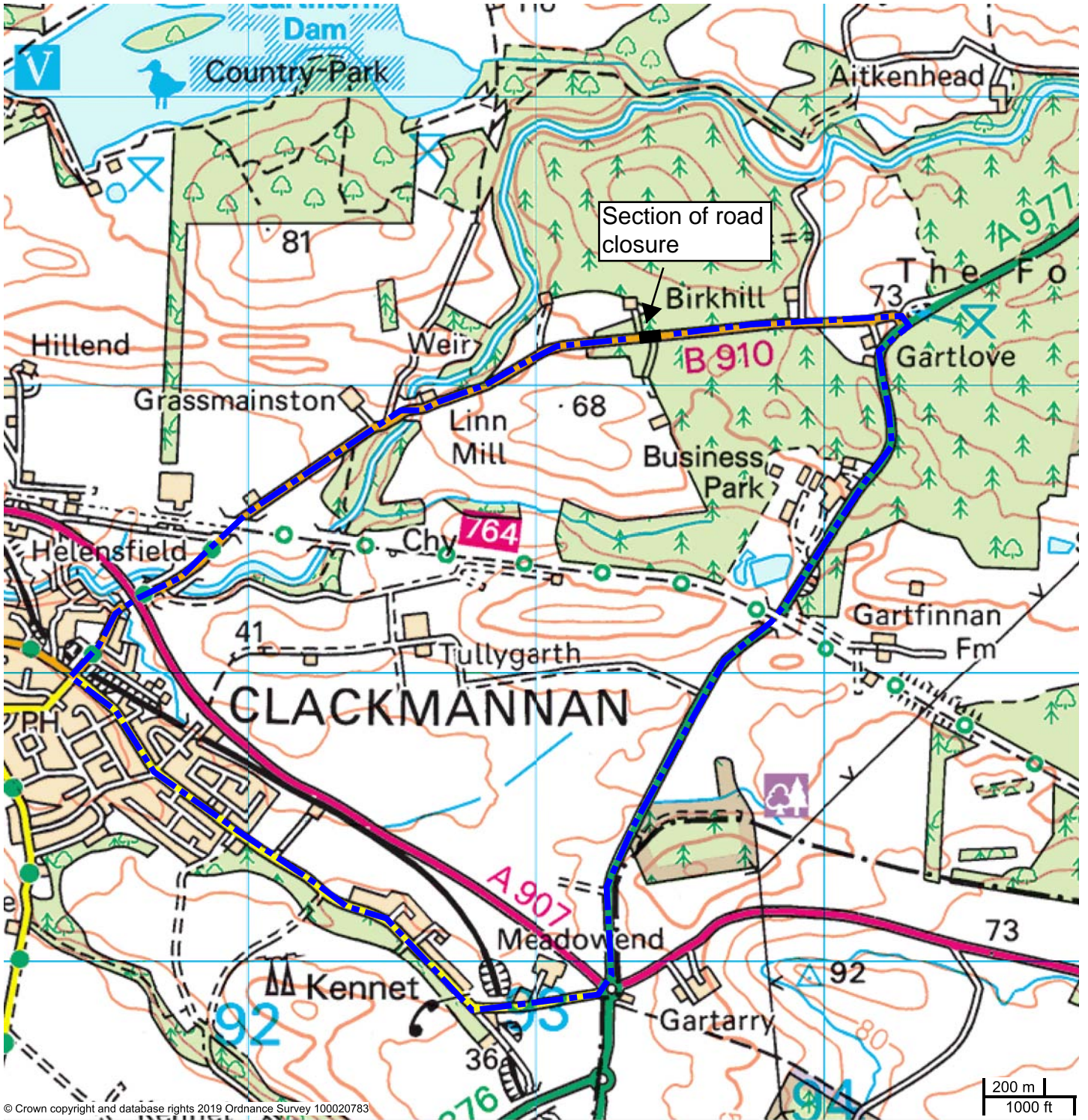
