



**(C89 FEARNS ROAD, FORESTMILL)
(TEMPORARY PROHIBITION OF DRIVING, PARKING AND LOADING) ORDER 2020**

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restriction) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

1. This Order may be cited as "The Clackmannanshire Council (C89 Fearn's Road, Forestmill) (Temporary Prohibition of Driving, Parking and Loading) Order 2020" and notwithstanding the date hereof, the Schedule shall come into operation at 0800 hours on Wednesday 1st April 2020 and will remain in operation for a period of 8 days or until works are complete whichever is soonest.
2. The effect of this Order is that there will be no driving, parking or loading at any time during:

The period from 0800 hours on Wednesday 1st April 2020 for a period of 8 days or until works are complete whichever is soonest, on the section of roads described in Schedule. The temporary prohibition of driving, parking and loading is to allow carriageway resurfacing.
