



**(MILL STREET, ALLOA)
(TEMPORARY REVERSAL OF ONE WAY) ORDER 2020**

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restrictions) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

1. This Order may be cited as "The Clackmannanshire Council (Mill Street, Alloa) (Temporary Reversal of One Way) Order 2020" and notwithstanding the date hereof shall come into operation at 0700 hours on until 1800 hours on following dates:
Friday 3rd April 2020, Friday 1st May 2020, Friday 5th June 2020, Friday 3rd July 2020, Friday 7th August 2020, Friday 4th September 2020, Friday 2nd October 2020, Friday 6th November 2020 and Friday 4th December 2020.

2. The effect of this Order shall be to suspend one way traffic during:-

The period from 0700 hours until 1800 hours on the following dates – Friday 3rd April 2020, Friday 1st May 2020, Friday 5th June 2020, Friday 3rd July 2020, Friday 7th August 2020, Friday 4th September 2020, Friday 2nd October 2020, Friday 6th November 2020 and Friday 4th December 2020, on the section of roads described in Schedule. The temporary reversal of the one way on Mill Street, Alloa is to allow access to the taxi rank.
