

(ANN STREET, TILLICOULTRY) (TEMPORARY PROHIBITION OF DRIVING, PARKING AND LOADING) ORDER 2020

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restriction) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

- 1. This Order may be cited as "The Clackmannanshire Council (Ann Street, Tillicoultry) (Temporary Prohibition of Driving, Parking and Loading) Order 2020" and notwithstanding the date hereof, the Schedule shall come into operation at 0930 hours on Thursday 14 May 2020 and will remain in operation until 0600 hours on Friday 15 May 2020.
- 2. The effect of this Order is that there will be no driving, parking or loading at any time during:

The period from 0930 hours on Thursday 14 May 2020 until 0600 hours on Friday 15 May 2020, on the section of roads described in Schedule. The temporary prohibition of driving, parking and loading is necessary to repair damaged ironworks in the centre of the carriageway.
