



**(ALLOA TOWN CENTRE)
(EXPERIMENTAL ROAD CLOSURE) ORDER 2020**

The Clackmannanshire Council, in exercise of the powers conferred on them by Sections 9 and 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restrictions) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

1. This Order may be cited as "The Clackmannanshire Council (Alloa Town Centre) (Experimental Road Closure) Order 2020" and notwithstanding the date hereof, Schedule shall come into operation at 0900 hours until 1800 hours each day from Tuesday 23rd June 2020 and will remain in operation for a period of 18 months.
2. The effect of this Order shall be to close to vehicles:-

During the period from 0900 hours until 1800 hours each day from Tuesday 23rd June 2020 for a period of 18 months, on the section of roads described in the Schedule. The experimental road closure is required due to COVID-19 and to make Safer Space for People. Exemptions being:

- A vehicle in the service of or employed by the Postmaster General is being used for the purposes of delivering or collecting postal packets as defined in Section 87 of the Post Office Act 1953.
- Construction vehicles being used in connection with any building operation or demolition, the removal of any obstruction to traffic, the maintenance improvement or reconstruction of any of the lengths of road so referred to, or the laying, erection, alteration or repair in or near to the said lengths of road of any sewer or main, pipe or apparatus for the supply of gas, water or electricity or any telecommunications apparatus as defined in subparagraph 1(1) of Schedule 2 to the Telecommunications Act.
- Where the vehicle is used for police, fire brigade or ambulance purposes or any vehicle in the service of the local authority in either case being used in pursuance of statutory power or duties.
- Where the vehicle is being used by a medical practitioner visiting patients on professional calls when such a vehicle bears, in a conspicuous position, the appropriate identification badge.
- Essential deliveries to shops and businesses.

- Construction vehicles being used in connection with any building operation or demolition, the removal of any obstruction to traffic, the maintenance improvement or reconstruction of any of the lengths of road so referred to, or the laying, erection, alteration or repair in or near to the said lengths of road of any sewer or main, pipe or apparatus for the supply of gas, water or electricity or any telecommunications apparatus as defined in subparagraph 1(1) of Schedule 2 to the Telecommunications Act.
- Where the vehicle is used for police, fire brigade or ambulance purposes or any vehicle in the service of the local authority in either case being used in pursuance of statutory power or duties.

The Clackmannanshire Council (Alloa Town Centre) (Experimental Road Closure) Order 2020

The Council has made "The Clackmannanshire Council (Alloa Town Centre) (Experimental Road Closure) Order 2020, under the Road Traffic Regulation Act 1984 (as amended) on 10th June 2020: to close to vehicles at **High Street, Alloa** (for its entirety, a distance of 125 metres or thereby); **Mill Street, Alloa** (from its junction with Mar Street north eastwards until its junction with Shillinghill, a distance of 123 metres or thereby). The order runs from 0900 hours until 1800 hours each day from Tuesday 23rd June 2020 for a period of 18 months.

The experimental road closure is required due to COVID-19 and to make Safer Space for People.

Exemptions being:

- A vehicle in the service of or employed by the Postmaster General is being used for the purposes of delivering or collecting postal packets as defined in Section 87 of the Post Office Act 1953.

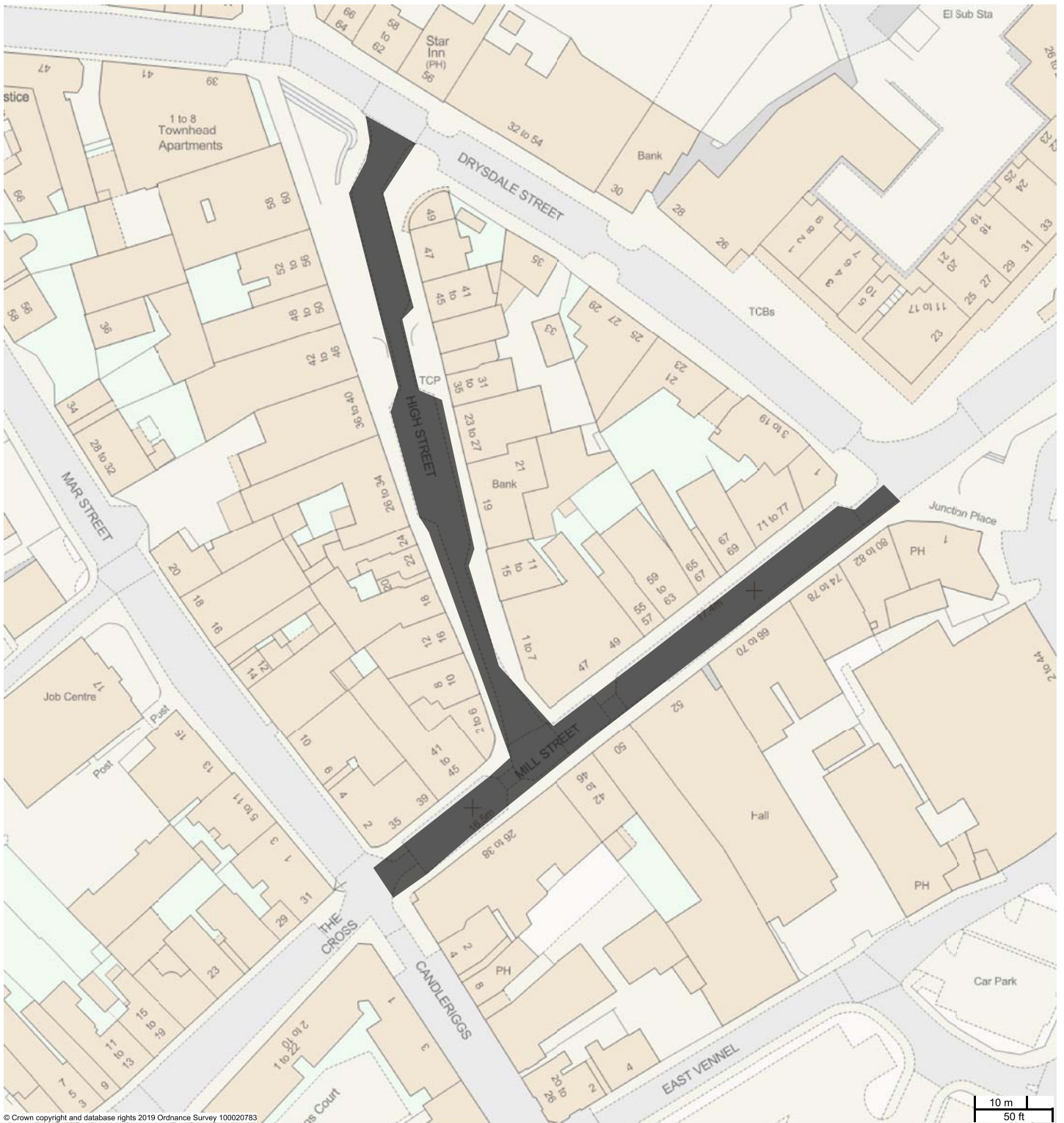
