

### (STIRLING STREET, ALVA) (TEMPORARY NO STOPPING ON FOOTWAY) ORDER 2020

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restrictions) Act 1991 and of all other powers enabling them in that behalf hereby make the following Order.

- 1. This Order may be cited as "The Clackmannanshire Council (Stirling Street, Alva) (Temporary No Stopping on Footway) Order 2020" and notwithstanding the date hereof shall come into operation at 0800 hours on Monday 6<sup>th</sup> July 2020 and will remain in operation for a period of 18 months.
- 2. The effect of this Order shall be to close to pedestrians:
  The period from 0800 hours on Monday 6<sup>th</sup> July 2020 for a period of 18 months, on the section described in the Schedule attached. The temporary no stopping on footway is to prevent stopping on the footway to allow pedestrians to adhere to social distancing and in accordance with Disability Discrimination Act 1997.

The Council has made "The Clackmannanshire Council (Stirling Street, Alva) (Temporary No Stopping on Footway) Order 2020", under the Road Traffic Regulation Act 1984 (as amended) on 11<sup>th</sup> June 2020: to close to pedestrians at **Stirling Street**, **Alva (A91)** (on the footway on the south side thereof: from its junction with Norton Street in a generally westerly direction, to its junction with Parkgate, a distance of 925 metres of thereby). The order runs from 0800 hours on Monday 6<sup>th</sup> July 2020 for a period of 18 months or until works are completed whichever is soonest, and is to prevent stopping on the footway to allow pedestrians to adhere to social distancing and in accordance with Disability Discrimination Act 1997.
