



**(VARIOUS STREETS, CLACKMANNANSHIRE)
(20 MPH SPEED LIMIT) EXPERIMENTAL ORDER 2020**

The Clackmannanshire Council, in exercise of the powers conferred on them by Sections 9 and 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restrictions) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

1. This Order may be cited as "The Clackmannanshire Council (Various Streets, Clackmannanshire) (20 mph Speed Limit) Experimental Order 2020" and notwithstanding the date hereof, Schedule shall come into operation on Monday 20th July 2020 and will remain in operation for a period of up to 18 months.
2. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament.
3. A speed limit of 20 miles per hour is hereby imposed on the lengths of roads specified in the Schedule to this Order and no person shall drive any motor vehicle at a speed exceeding 20 miles per hour on the said lengths of roads.
4. The restriction imposed by this Order shall be in addition to and not in derogation of any restriction or requirement imposed by any regulations made or having effect as if made under the Road Traffic Regulation Act 1984 or by or under any other enactment.
5. The Director (Place) of Clackmannanshire Council may, if it appears to him essential in the interests of the expeditious, convenient, or safe movement of traffic, or for preserving or improving the amenities of the area, and after such consultation and notice as are required by law, modify or suspend the operation of this Order or any provisions of it in accordance with Section 10(2) of said Act.

The experimental traffic order is required to reduce traffic speed on streets that have experienced increased pedestrian and cycling use since the implementation of the COVID-19 Lockdown. The speed limit is in the interests of road safety. The experimental traffic order will be used to monitor the effectiveness of the new speed limit on these roads.

The Clackmannanshire Council (Various Streets, Clackmannanshire) (20 mph Speed Limit) Experimental Order 2020

The Council has made the above Order under Sections 9, 10(2), 84(1) and (2) and Part IV of Schedule 9 to the Road Traffic Regulation Act 1984. This will designate the sections of roads in Clackmannanshire: **A91 Menstrie**; From a point 2 metres west of the west kerb-line of Midtown in an easterly direction to its junction with Forthvale a distance of 308 metres or thereby, **A91 Alva**; From a point 28 metres west of the west kerb-line of Cobblecrook Gardens in an easterly direction to a point 63 metres west of the west kerb-line of Norton Street a distance of 648 metres or thereby, **A91 Tillicoultry**; From a point 15 metres west of the west kerb-line of Union Street in an easterly direction to a point 5 metres west of the west kerb-line of Murray Square exit road a distance of 380 metres or thereby, **A91 Dollar**; From the west kerb-line of Manor House Road in an easterly direction to a point 17m west of the west kerb-line of Lover's Loan a distance of 482 metres or thereby, **B913 Devon Road, Dollar**; From its junction with A91 Bridge Street in a southerly direction to a point 159 metres south of the extended south kerb-line of Dewar Street a distance of 287 metres or thereby, as a 20 miles per hour speed limit for a period of up to 18 months to reduce traffic speed on roads that have experienced increased pedestrian and cycling use since the implementation of the COVID-19 Lockdown and is in the interests of road safety. 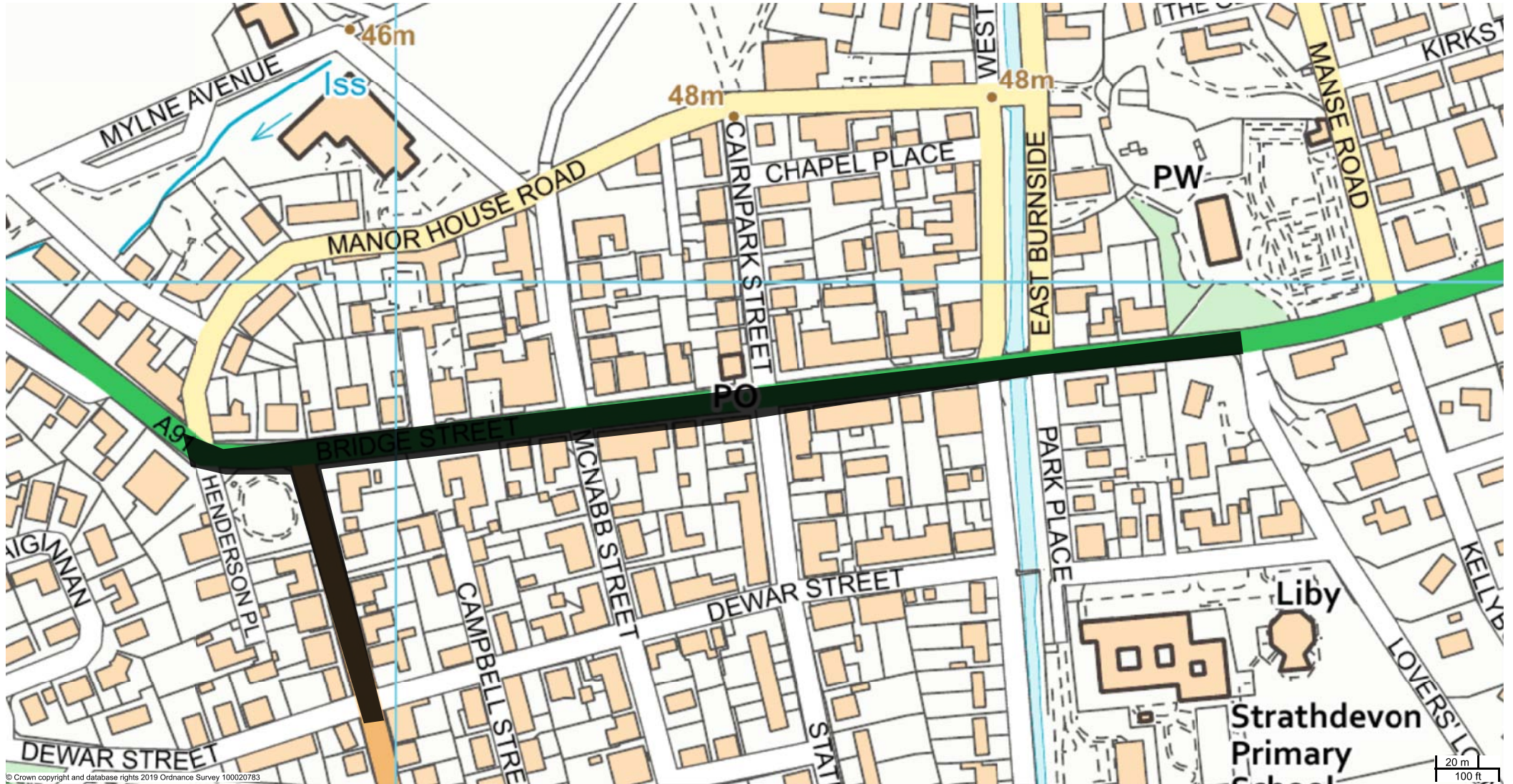

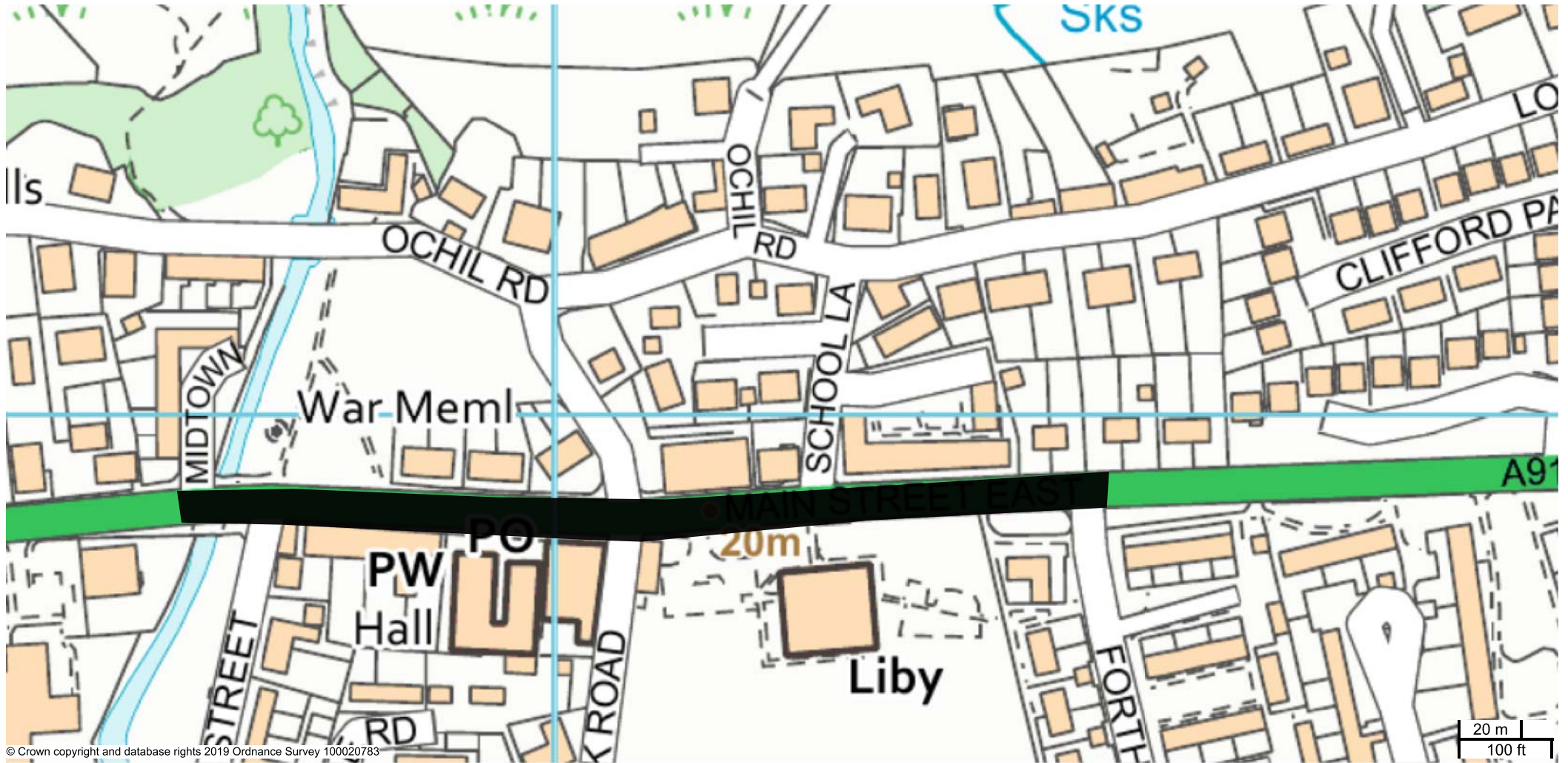

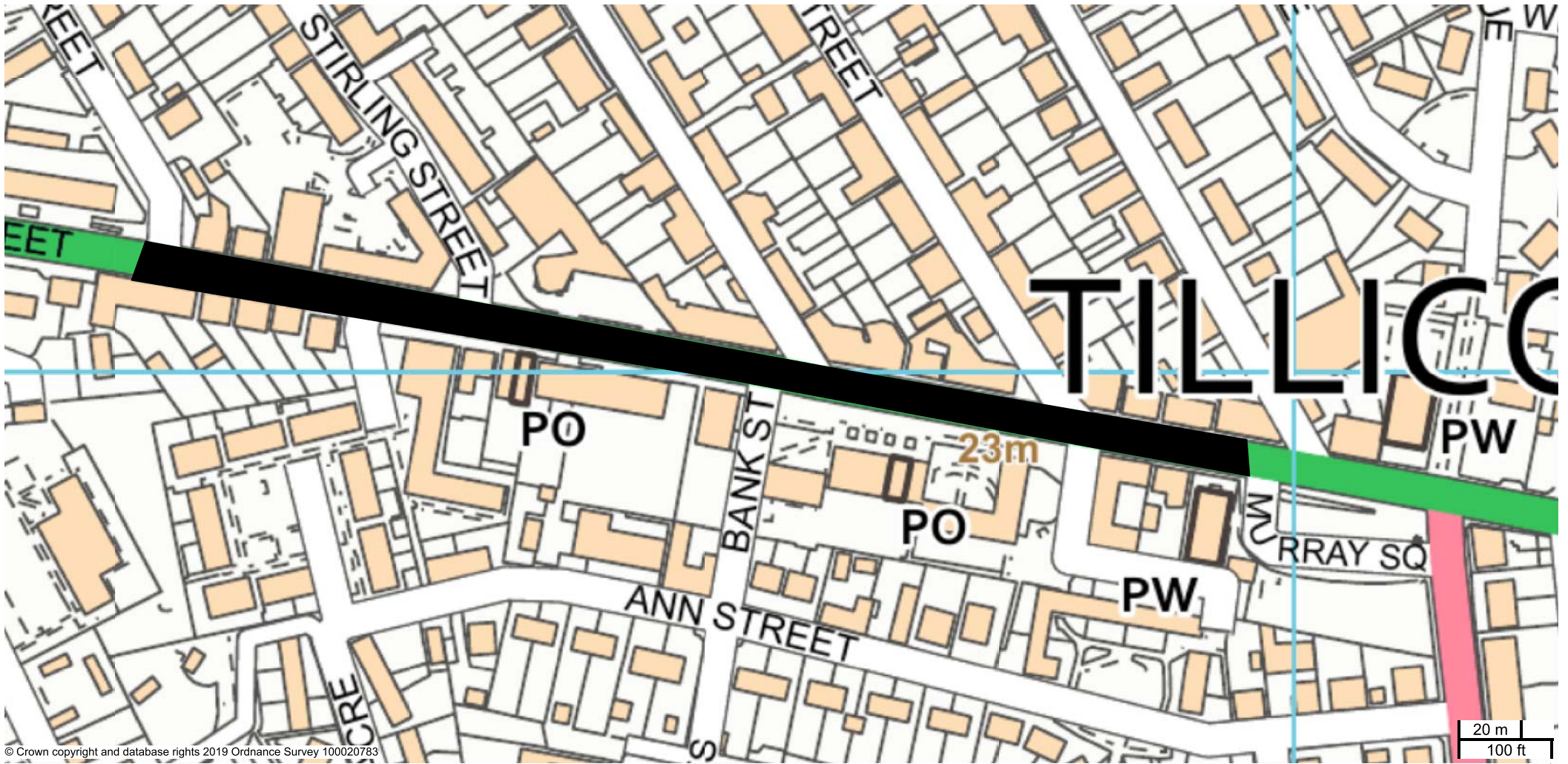
Experimental 20mph limit - A91 Alva
