

(HILLFOOTS ROAD, MENSTRIE TO ALVA) (EXPERIMENTAL PROHIBITION OF VEHICLES) (AMENDMENT NO. 1) ORDER 2020

The Clackmannanshire Council, in exercise of the powers conferred on them by Sections 9 and 10 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restrictions) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

- This Order may be cited as "The Clackmannanshire Council (Hillfoots Road, Menstrie to Alva) (Experimental Prohibition of Vehicles) Order 2020" and notwithstanding the date hereof, shall come into operation at 0800 hours on Monday 28 December 2020 and will remain in operation for a maximum period of up to 18 months.
- 2. The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an Act of Parliament
- This order amends "The Clackmannanshire Council (Hillfoots Road, Menstrie to Alva) (Experimental Prohibition of Vehicles) Order 2020 by adding additional clauses to the Order and sets out exemptions in Clause 4 (a) to (d).
- 4. The effect of this Order makes it unlawful for any person to drive or cause or permit to be driven any motor vehicle, except authorised vehicles, on the sections of roads as set out in the Schedule with the undernoted exemptions:
 - a. Where construction vehicles are being used in connection with the removal of any obstruction to traffic, the maintenance improvement or reconstruction of any of the lengths of road so referred to, or the laying, erection, alteration or repair in or near to the said lengths of road of any sewer or main, pipe or apparatus for the supply of gas, water or electricity or any telecommunications apparatus as defined in subparagraph 1(1) of Schedule 2 to the Telecommunications Act.
 - b. Where the vehicle is used for police, fire brigade or ambulance purposes or any vehicle in the service of the local authority in either case being used in pursuance of statutory power or duties.
 - c. Where the vehicle is being used by a medical practitioner visiting patients on professional calls when such a vehicle bears, in a conspicuous position, the appropriate identification badge.
 - d. For essential deliveries to adjacent properties, which due to vehicle size, are unable to gain access by another route.
- 5. The restriction imposed by this Order shall be in addition to and not in derogation of any restriction or requirement imposed by any regulations made or having effect as if made under the Road Traffic Regulation Act 1984 or by or under any other enactment.

6. The Director (Place) of Clackmannanshire Council may, if it appears to him essential in the interests of the expeditious, convenient, or safe movement of traffic, or for preserving or improving the amenities of the area, and after such consultation and notice as are required by law, modify or suspend the operation of this Order or any provisions of it in accordance with Section 10(2) of said Act.

The Clackmannanshire Council (Hillfoots Road, Menstrie to Alva) (Experimental Prohibition of Vehicles) (Amendment No. 1) Order 2020

The Council has made "The Clackmannanshire Council (Hillfoots Road, Menstrie to Alva) (Experimental Prohibition of Vehicles) (Amendment No. 1) Order 2020, under the Road Traffic Regulation Act 1984 (as amended) on 10 December 2020 for the purposes of road safety and to encourage active travel. Schedule: Side and Section of Road where vehicles will be prohibited - Hillfoots Road, Menstrie to Alva (From a point 6 metres east of the access road to Mairtoun Hill Steading in an easterly direction to a point 160 metres west of the vehicular access to Myretoun Cottage a distance of 320 metres or thereby). Exemptions to the order are set out below: (a) Where construction vehicles are being used in connection with the removal of any obstruction to traffic, the maintenance improvement or reconstruction of any of the lengths of road so referred to, or the laying, erection, alteration or repair in or near to the said lengths of road of any sewer or main, pipe or apparatus for the supply of gas, water or electricity or any telecommunications apparatus as defined in subparagraph 1(1) of Schedule 2 to the Telecommunications Act. (b) Where the vehicle is used for police, fire brigade or ambulance purposes or any vehicle in the service of the local authority in either case being used in pursuance of statutory power or duties (c) Where the vehicle is being used by a medical practitioner visiting patients on professional calls when such a vehicle bears, in a conspicuous position, the appropriate identification badge and (d) For essential deliveries to adjacent properties, which due to vehicle size, are unable to gain access by another route. The Clackmannanshire Council has made the above named Order under Sections 9 and 10 of the Road Traffic Regulation Act 1984 (as amended) and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to said Act and having complied with the statutory requirements of The Local Authorities' Traffic Orders (Procedure) (Scotland) Regulations 1999, on 10 December 2020.

The Experimental Order is required for the purpose of road safety and to encourage active travel.

This Order makes it unlawful for any person to drive or cause or permit to be driven any motor vehicle, except authorised vehicles, at any time during the period from 0800 hours on Monday 28 December 2020 for a maximum period of up to 18 months, on the section of road described in the Schedule. Exemptions being:

- a. Where construction vehicles are being used in connection with the removal of any obstruction to traffic, the maintenance improvement or reconstruction of any of the lengths of road so referred to, or the laying, erection, alteration or repair in or near to the said lengths of road of any sewer or main, pipe or apparatus for the supply of gas, water or electricity or any telecommunications apparatus as defined in subparagraph 1(1) of Schedule 2 to the Telecommunications Act.
- b. Where the vehicle is used for police, fire brigade or ambulance purposes or any vehicle in the service of the local authority in either case being used in pursuance of statutory power or duties.
- c. Where the vehicle is being used by a medical practitioner visiting patients on professional calls when such a vehicle bears, in a conspicuous position, the appropriate identification badge.
- d. For essential deliveries to adjacent properties, which due to vehicle size, are unable to gain access by another route.


