



**(PORT STREET, CLACKMANNAN)
(TEMPORARY PROHIBITION OF DRIVING, PARKING AND LOADING) ORDER 2020**

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restriction) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

1. This Order may be cited as "The Clackmannanshire Council (Port Street, Clackmannan) (Temporary Prohibition of Driving, Parking and Loading) Order 2020" and notwithstanding the date hereof, the Schedule shall come into operation at 0930 hours on Tuesday 12th January 2021 and will remain in operation until 1800 hours on that day.
2. The effect of this Order is that there will be no driving, parking or loading at any time during:

The period from 0930 hours until 1800 hours on Tuesday 12th January 2021, on the section of roads described in Schedule. The temporary prohibition of driving, parking and loading is necessary to repair damaged ironworks.

The Council has made "The Clackmannanshire Council (Port Street, Clackmannan) (Temporary Prohibition of Driving, Parking and Loading) Order 2020, under the Road Traffic Regulation Act 1984 (as amended) on 10th December 2020: where there will be a temporary prohibition of driving, parking and loading at **Port Street, Clackmannan** (from its junction with Lochies Road northwards to its junction with Craigrie Road , a distance of 50 metres or thereby). Diversion: Via Port Street, Kirk Wynd, Alloa Road, Cattle Market, Castle Street, Lochies Road and vice versa. The order runs from 0930 hours until 1800 hours on Tuesday 12th January 2021. 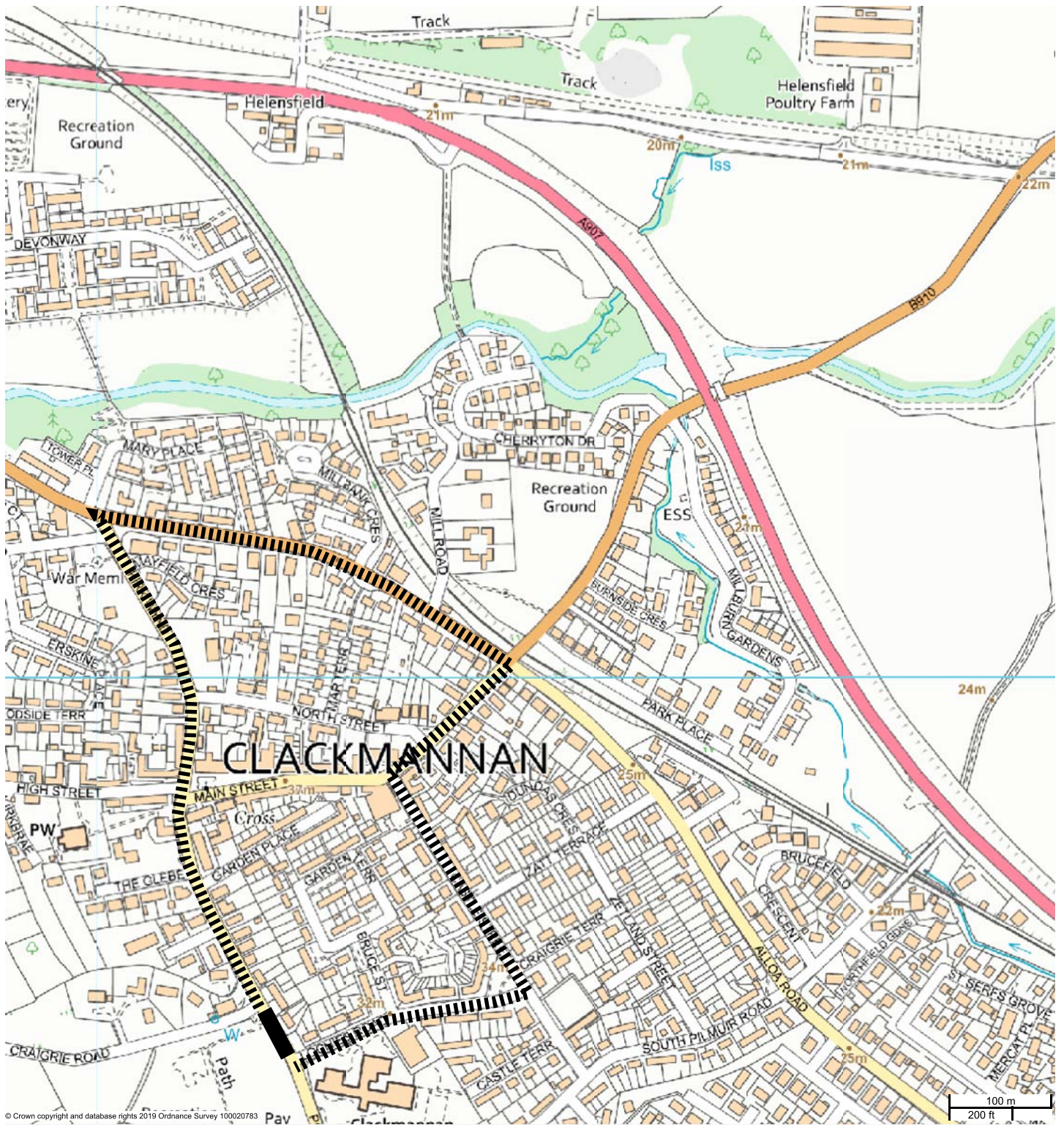
