



**(BANK STREET, TILlicOUNTRY)  
(TEMPORARY PROHIBITION OF DRIVING, PARKING AND LOADING) ORDER 2021**

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restriction) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

1. This Order may be cited as "The Clackmannanshire Council (Bank Street, Tillicoultry) (Temporary Prohibition of Driving, Parking and Loading) Order 2021" and notwithstanding the date hereof, the Schedule shall come into operation at 0800 hours on Monday 22<sup>nd</sup> February 2020 and will remain in operation until 1700 hours on that day.
2. The effect of this Order is that there will be no driving, parking or loading at any time during:

The period from 0800 hours until 1700 hours on Monday 22<sup>nd</sup> February 2021, on the section of roads described in Schedule. The temporary prohibition of driving, parking and loading is necessary to allow access to manhole on carriageway to carry out repairs .

The Council has made "The Clackmannanshire Council (Bank Street, Tillicoultry) (Temporary Prohibition of Driving, Parking and Loading) Order 2021, under the Road Traffic Regulation Act 1984 (as amended) on 20<sup>th</sup> January 2021: where there will be a temporary prohibition of driving, parking and loading at **Bank Street, Tillicoultry** (from it junction with A91 High Street southwards for a distance of 20 metres or thereby). Diversion: Via Ann Street, Moss Road, High Street and vice versa. The order runs from 0800 hours until 1700 hours on Monday 22<sup>nd</sup> February 2021. 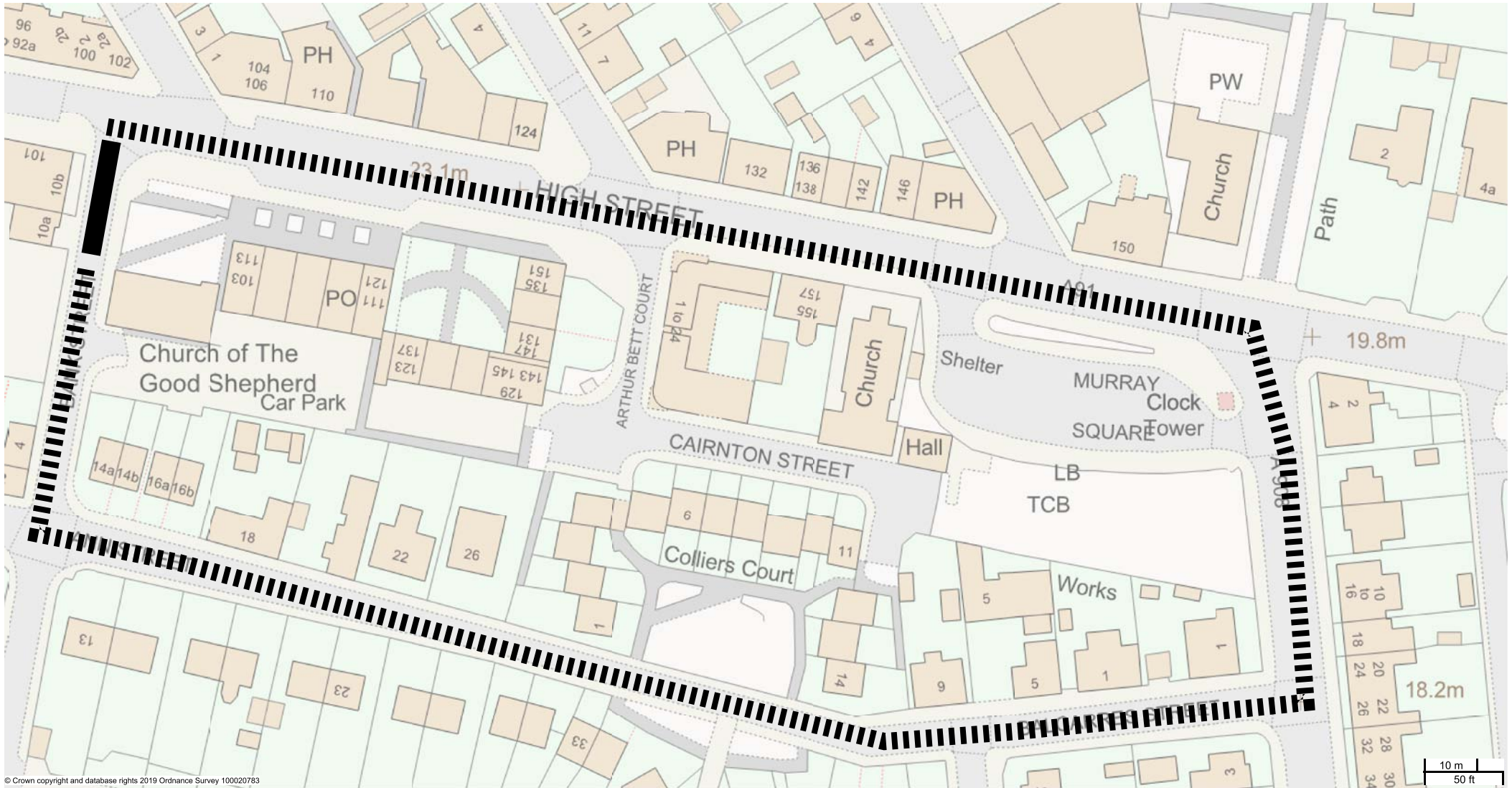
