



**(A907 CLACKMANNAN ROAD, ALLOA)
(TEMPORARY ROAD CLOSURE) ORDER 2021**

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restrictions) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

1. This Order may be cited as "The Clackmannanshire Council (A907 Clackmannan Road, Alloa) (Temporary Road Closure) Order 2021" and notwithstanding the date hereof, Schedule shall come into operation at 0800 hours on Sunday 28th March 2021 and will remain in operation until 1400 hours on that day.
2. The effect of this Order shall be to close to vehicles:-

During the period from 0800 hours until 1400 hours on Sunday 28th March 2021, on the section of roads described in Schedule. The temporary closure is required for essential carriageway resurfacing, this will protect the workforce and members of the public.

Diversion: Via A908 Whins Road, B909 Alloa Eastern Link Road, A907 Clackmannan Road and vice versa. 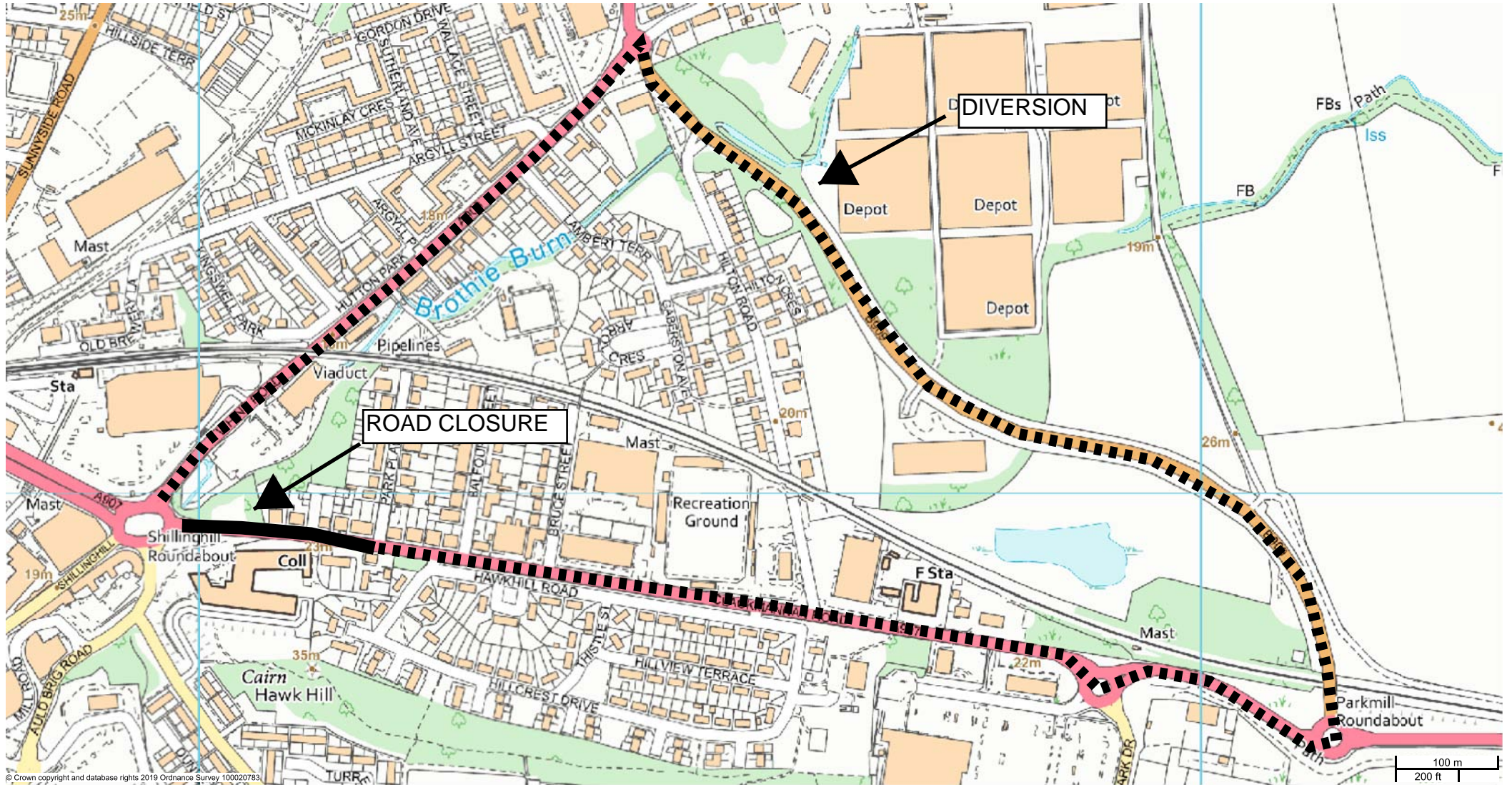
