



**(B9140 PITFAIRN ROAD, FISHCROSS)

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restrictions) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

1. This Order may be cited as "The Clackmannanshire Council (B9140 Pitfairn Road, Fishcross) (Temporary Road Closure) Order 2021" and notwithstanding the date hereof, Schedule shall come into operation at 0600 hours on Saturday 10<sup>th</sup> April 2021 and will remain in operation until 1600 hours on Wednesday 21<sup>st</sup> April 2021.
2. The effect of this Order shall be to close to vehicles:-

During the period from 0600 hours on Saturday 10<sup>th</sup> April 2021 until 1600 hours on Wednesday 14<sup>th</sup> April 2021, on the section of roads described in Schedule 1 and from 1600 hours on Thursday 15<sup>th</sup> April 2021 until 1600 hours on Wednesday 21<sup>st</sup> April 2021 on the section of roads described in Schedule 2. The temporary closure is required for essential carriageway reconstruction and resurfacing and to protect the workforce and members of the public.

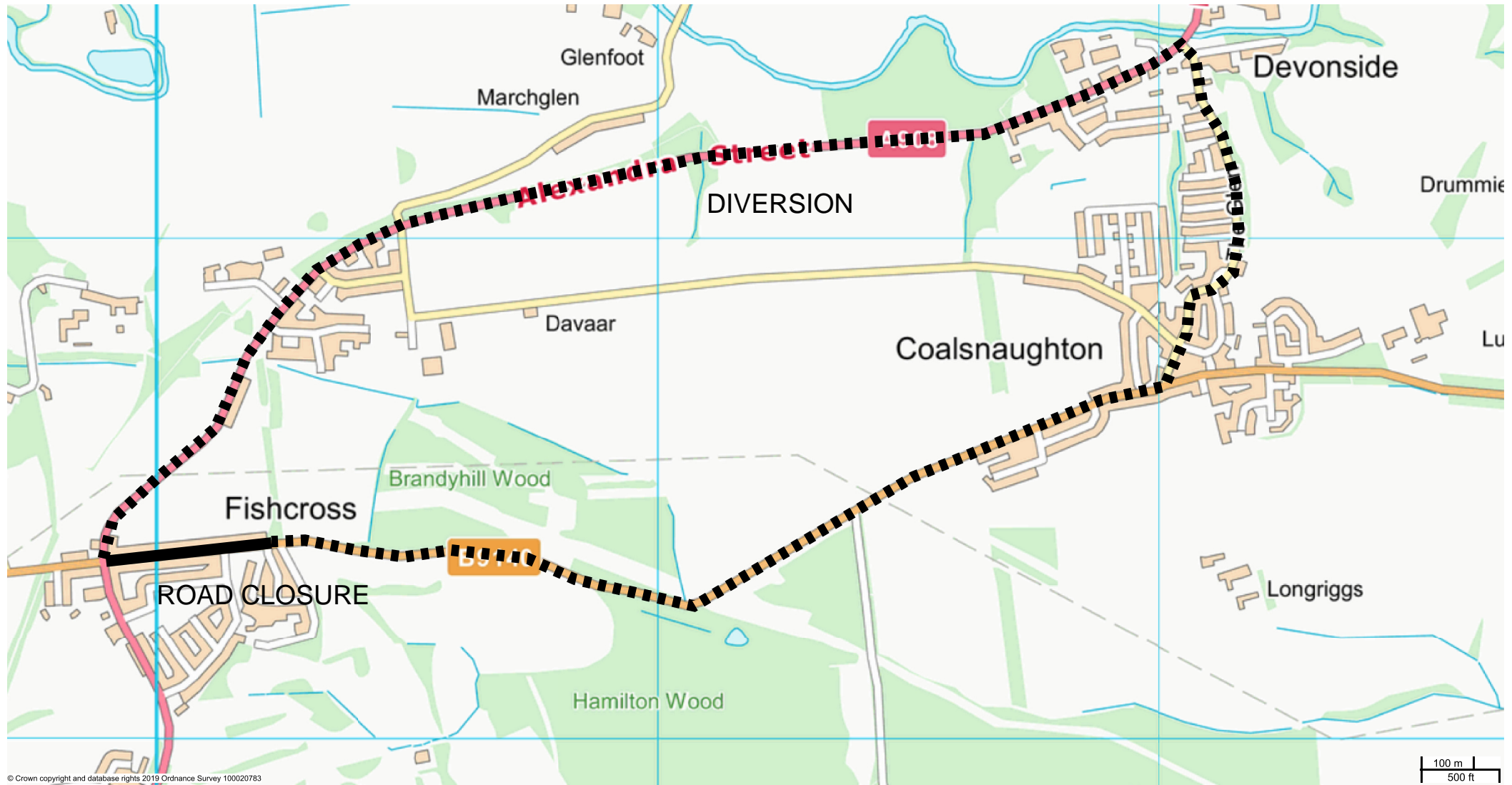
