The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restrictions) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

1. This Order may be cited as "The Clackmannanshire Council (Mill Street, Alloa) (Temporary Reversal of One Way) Experimental Order 2021" and notwithstanding the date hereof shall come into operation at 0700 hours on Monday 19 April 2021, for a period of up to 18 months..
2. The effect of this Order shall be to reverse one way traffic during:-

The period from 0700 hours on Monday 19 April 2021 for a period of up to 18 months, on the sections of road described in Schedule. The experimental temporary reversal of the one way on Mill Street, Alloa is due to COVID-19 to make Safer Spaces for People.
