



**(KNOWFAULDS ROAD AND REDLANDS ROAD, TULLIBODY)
(TEMPORARY ROAD CLOSURE) ORDER 2021**

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restrictions) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

1. This Order may be cited as "The Clackmannanshire Council (Knowfaulds Road and Redlands Road, Tullibody) (Temporary Road Closure) Order 2021" and notwithstanding the date hereof, Schedule shall come into operation at 0800 hours on Monday 3 May 2021 and will remain in operation until 1700 hours on Friday 28 May 2021.
2. The effect of this Order shall be to close to vehicles:-

During the period from 0800 hours on Monday 3 May 2021 until 1700 hours on Friday 28 May 2021 on the section of roads described in the Schedule. The temporary closure is required for essential carriageway reconstruction and resurfacing and to protect the workforce and members of the public.

The Council has made "The Clackmannanshire Council (Knowfaulds Road and Redlands Road, Tullibody) (Temporary Road Closure) Order 2021, under the Road Traffic Regulation Act 1984 (as amended) on 13/04/21: to close to vehicles the sections of road at **Knowfaulds Road, Tullibody** (From its junction with Stirling Road northwards until its junction with St Serf's Road, a distance of 170 metres or thereby). **Diversion** – Via St Serf's Road, Dovecot Place, Dovecot Road, Ladywell Place, Ladywell Drive, Stirling Road and vice versa. **Redlands Road, Tullibody** (From its junction with Knowfaulds Road, a distance of 165 metres). **Diversion** - No diversion available (The order runs from 0800 hours on Monday 3 May 2021 until 1700 hours on Friday 28 May 2021 and is required for essential carriageway reconstruction and resurfacing and to protect the workforce and members of the public. 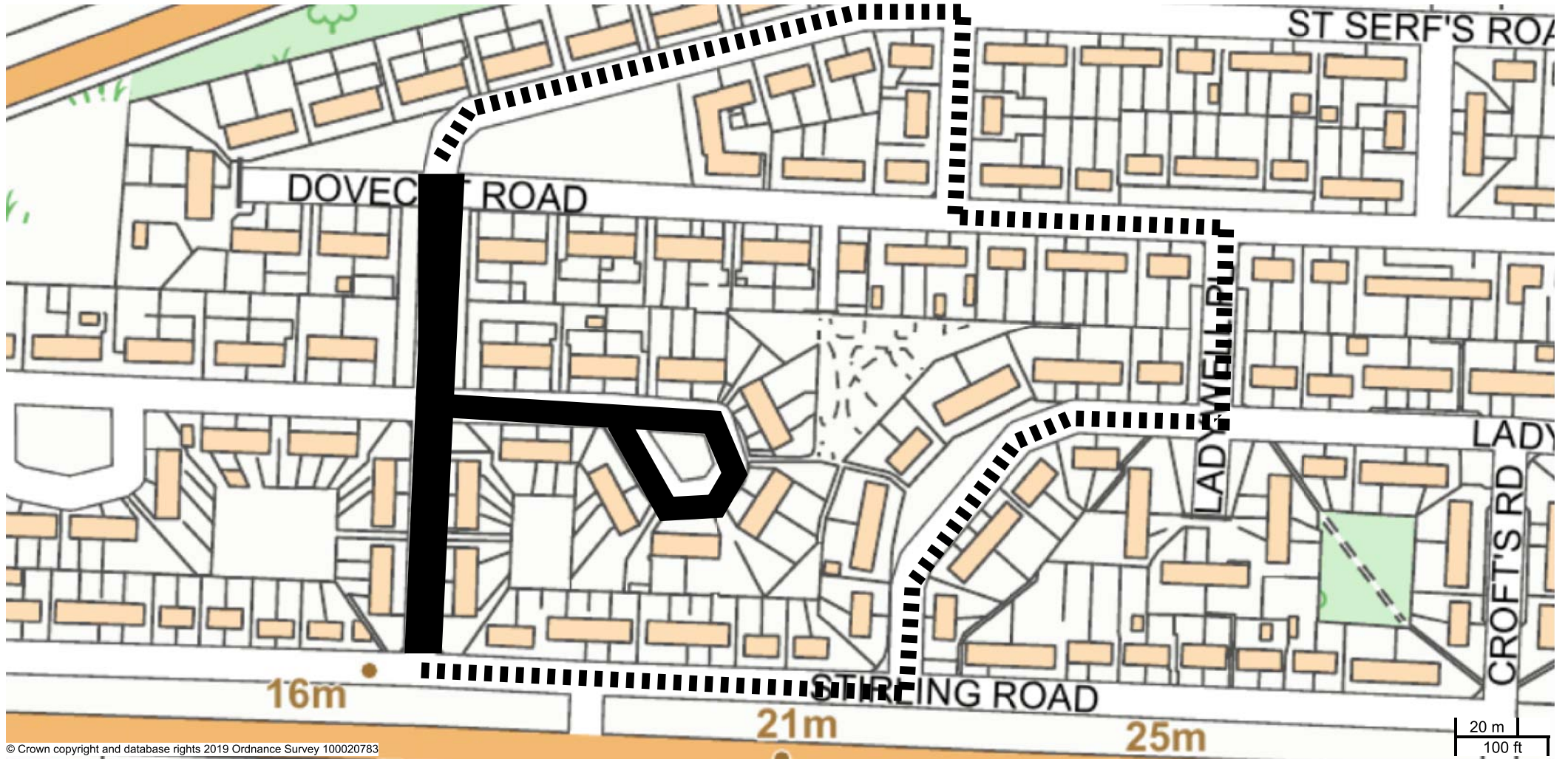
