



**(MARSHILL CAR PARK NORTH ENTRANCE, ALLOA)
(TEMPORARY ROAD CLOSURE) ORDER 2021**

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restrictions) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

1. This Order may be cited as "The Clackmannanshire Council (Marshall Car Park North Entrance, Alloa) (Temporary Road Closure) Order 2021" and notwithstanding the date hereof, Schedule shall come into operation at 0700 hours on Monday 17 May 2021 and will remain in operation until 1700 hours on Friday 21 May 2021.
2. The effect of this Order shall be to close to vehicles:-

During the period from 0700 hours on Monday 17 May 2021 until 1700 hours on Friday 21 May 2021 on the section of roads described in the Schedule. The temporary closure is required for a road crossing and to protect the workforce and members of the public.

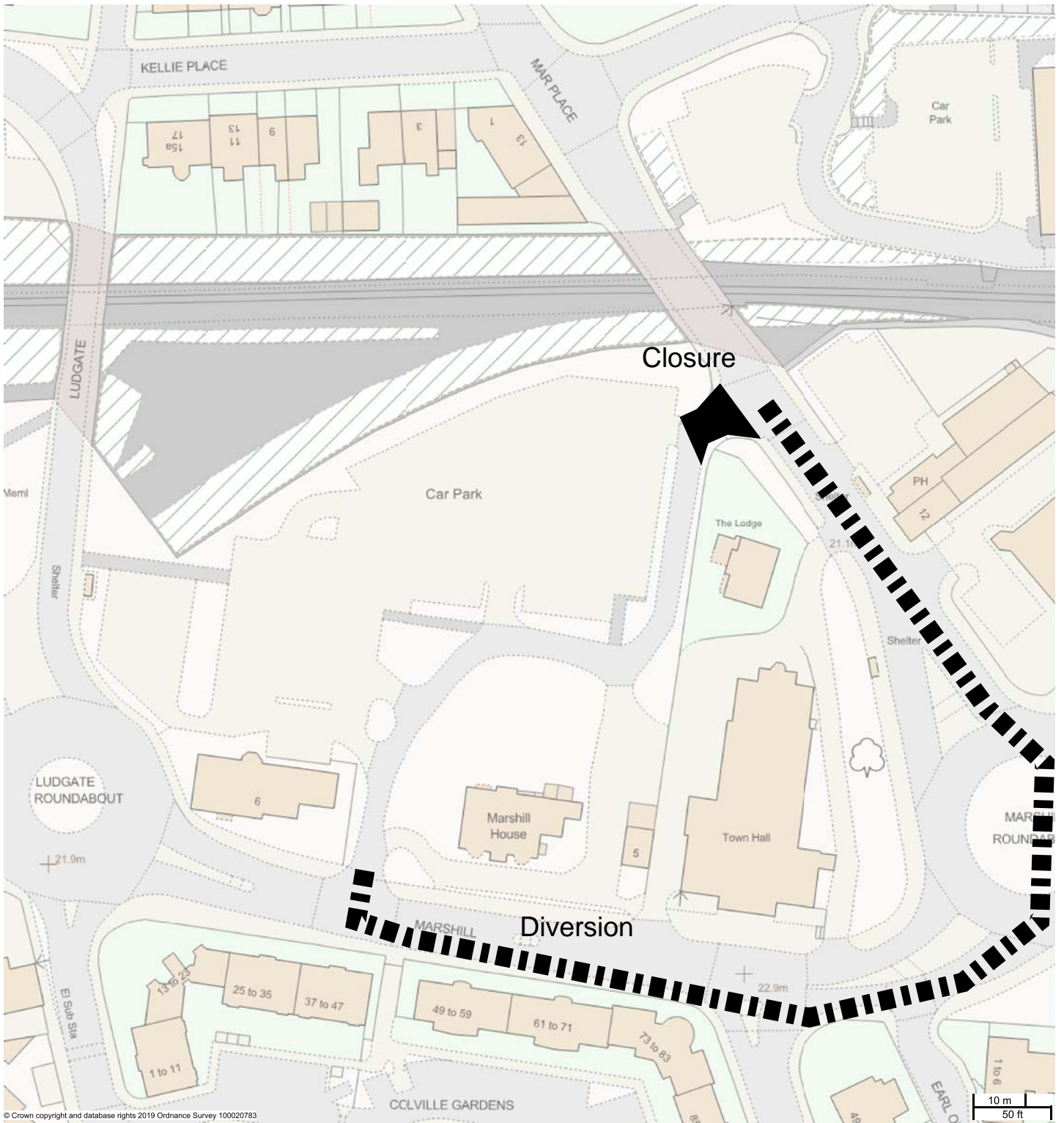
