

(BURNSIDE FARM ROAD, ALVA) (TEMPORARY ROAD CLOSURE) ORDER 2021

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restrictions) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

- This Order may be cited as "The Clackmannanshire Council (Burnside Farm Road, Alva) (Temporary Road Closure) Order 2021" and notwithstanding the date hereof, Schedule shall come into operation at 0800 hours on Monday 10 May 2021 for a period of four weeks.
- 2. The effect of this Order shall be to close to vehicles:-

From 0800 hours on Monday 10 May 2021 for a period of four weeks, on the section of roads described in the Schedule. The temporary closure is required for JML Contractors to carry out works that require the road to be closed.


