

(HIGH STREET, ALLOA) (TEMPORARY PROHIBITION OF DRIVING, PARKING AND LOADING) ORDER 2021

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restriction) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

This Order may be cited as "The Clackmannanshire Council (High Street, Alloa) (Temporary Prohibition of Driving, Parking and Loading) Order 2021" and notwithstanding the date hereof, the Schedule shall be in operation from 0700 hours until 1800 hours on: Friday 4th June 2021, Friday 2nd July 2021, Friday 6th August 2021, Friday 3rd September 2021, Friday 1st October 2021, Friday 5th November 2021 and Friday 3rd December 2021.
- 2. The effect of this Order is that there will be no driving, parking or loading at any time during:
