



**(MITCHELL CRESCENT, ALLOA)
(TEMPORARY PROHIBITION OF DRIVING, PARKING AND LOADING) ORDER 2021**

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restriction) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

1. This Order may be cited as "The Clackmannanshire Council (Mitchell Crescent, Alloa) (Temporary Prohibition of Driving, Parking and Loading) Order 2021" and notwithstanding the date hereof, the Schedule shall come into operation at 0800 hours on Monday 28th June 2021 and will remain in operation for a period of 3 days.
2. The effect of this Order is that there will be no driving, parking or loading at any time during:

The period from 0800 hours on Monday 28th June 2021 for a period of 3 days, on the section of roads described in Schedule. The temporary prohibition of driving, parking and loading is necessary to allow clearing of a blockage in the carriageway.

The Council has made "The Clackmannanshire Council (Mitchell Crescent, Alloa) (Temporary Prohibition of Driving, Parking and Loading) Order 2021, under the Road Traffic Regulation Act 1984 (as amended) on 8th June 2021: where there will be a temporary prohibition of driving, parking and loading at **Mitchell Crescent, Alloa** (from a point 81 metres from its junction with Dirleton Gardens, westwards for a distance of 26 metres or thereby). Diversion: Via Mitchell Crescent, Dirleton Gardens, Smithfield Loan, Alloa. The order runs from 0800 hours on Monday 28th June 2021 for a period of 3 days. 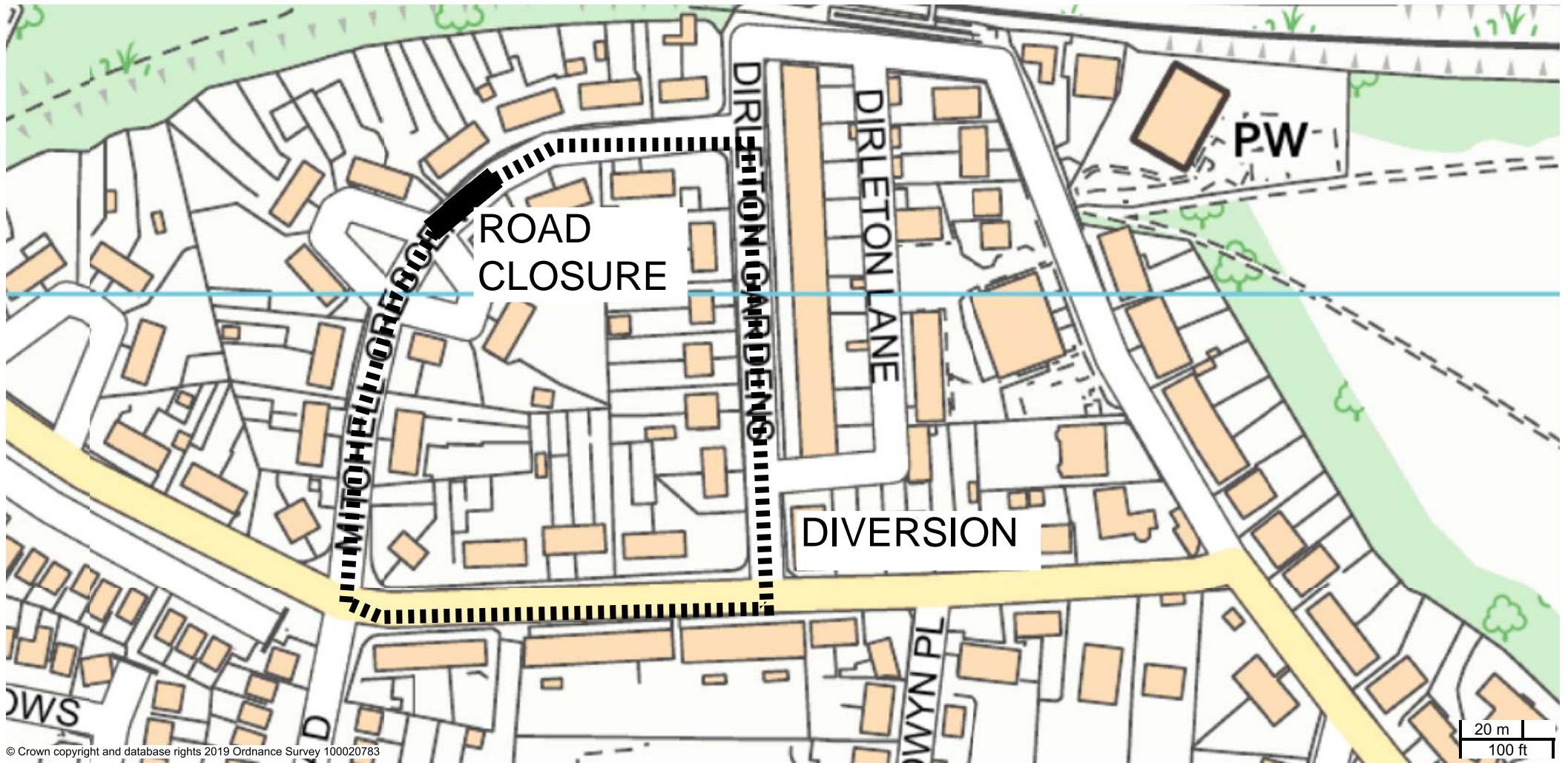
