



**(A907 KING STREET, ALLOA)  
(TEMPORARY PROHIBITION OF DRIVING, PARKING AND LOADING) ORDER 2021**

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restriction) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

1. This Order may be cited as "The Clackmannanshire Council (A907 King Street, Alloa) (Temporary Prohibition of Driving, Parking and Loading) Order 2021" and notwithstanding the date hereof, the Schedule shall come into operation at 0600 hours on Monday 28<sup>th</sup> June 2021 and will remain in operation until 2359 hours on Sunday 4<sup>th</sup> July 2021 (Schedule 1) and at 2359 hours on Sunday 4<sup>th</sup> July 2021 until 2359 hours on Sunday 11<sup>th</sup> July 2021 (Schedule 2).
  
2. The effect of this Order is that there will be no driving, parking or loading at any time during:

The period from 0600 hours on Monday 28<sup>th</sup> June 2021 until 2359 hours on Sunday 4<sup>th</sup> July 2021 (Schedule 1) and from 2359 hours on Sunday 4<sup>th</sup> July 2021 until 2359 hours on Sunday 11<sup>th</sup> July 2021 (Schedule 2) , on the section of roads described in Schedule. The temporary prohibition of driving, parking and loading is necessary to allow resurfacing works on the full carriageway.

### Schedule 1

From its junction with Marshill Roundabout eastwards until Station Roundabout, a distance of 242 metres or thereby. Diversion: Via A9076, B908, Fairfield, A908, B909, A907 and vice versa.

The order runs from 0600 hours on Monday 28<sup>th</sup> June 2021 until 2359 hours on Sunday 4<sup>th</sup> July 2021

### Schedule 2

From its junction with Station Roundabout eastwards until Shillinghill Roundabout, a distance of 175 metres or thereby. Diversion: Via A907, B908, Fairfield, A908, B909, A907 and vice versa.

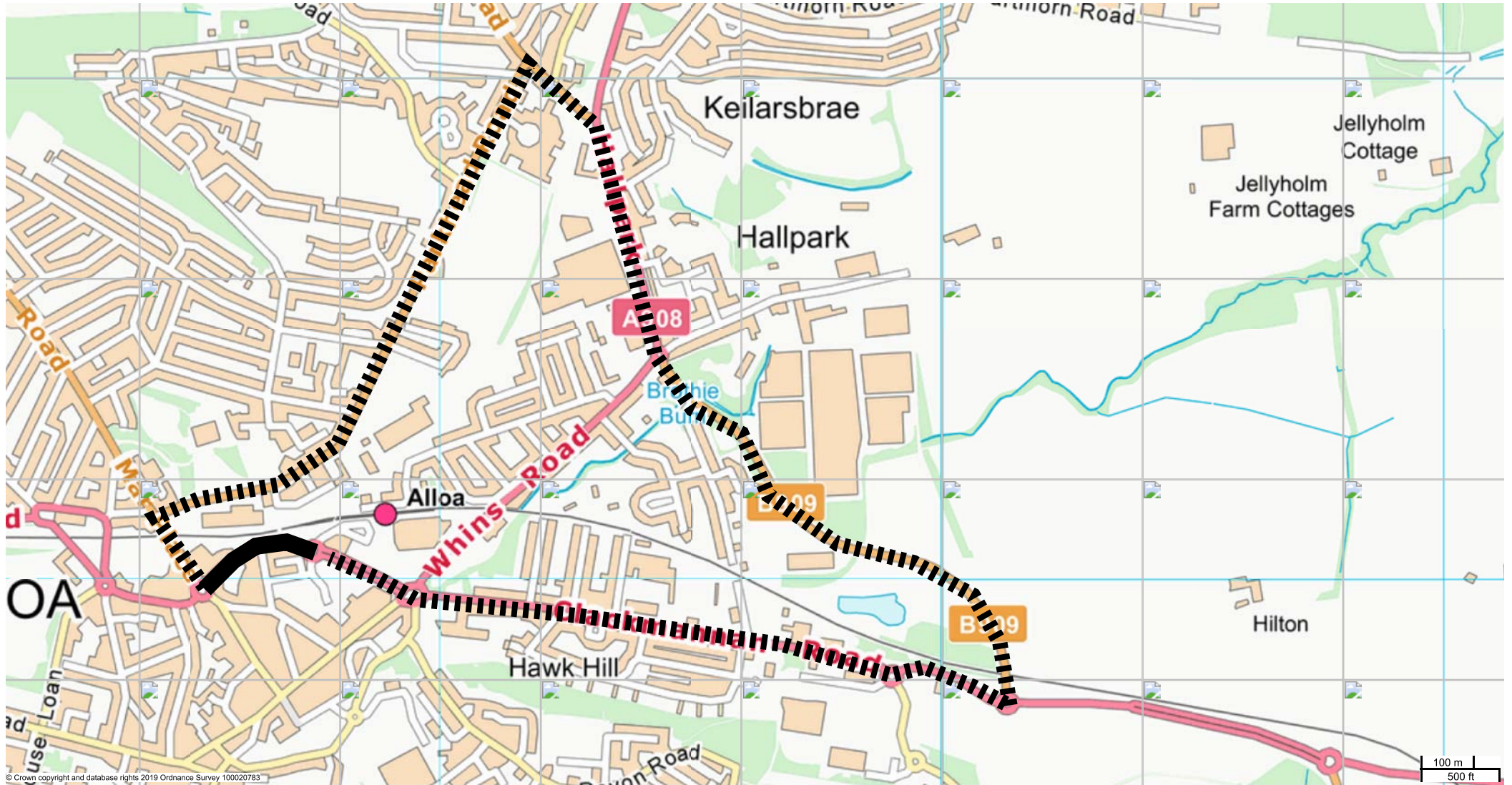

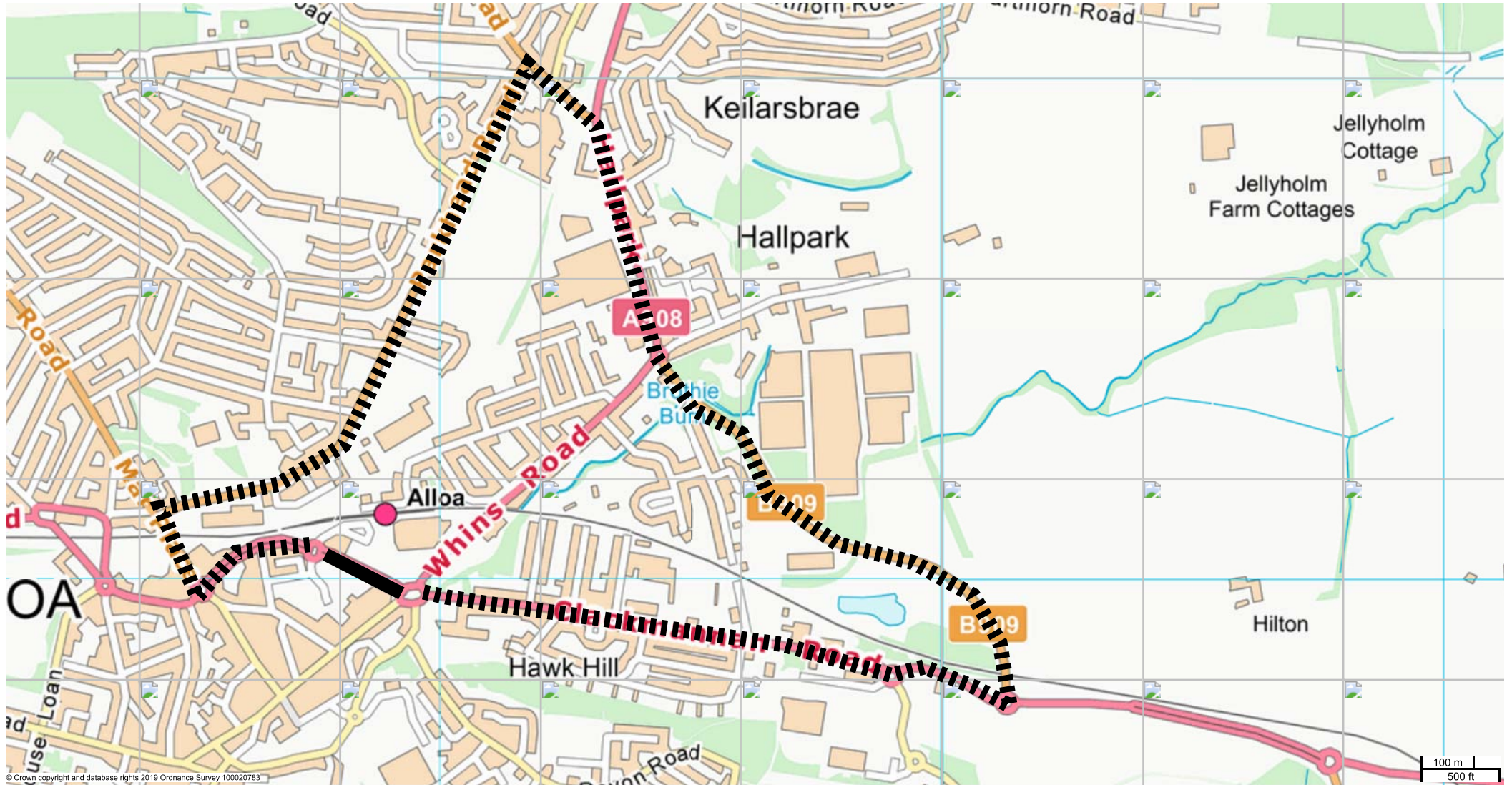
