

(A91 DOLLAR TO POOL O'MUCKHART) (TEMPORARY SPEED RESTRICTION) ORDER 2021

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restrictions) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

- This Order may be cited as "The Clackmannanshire Council (A91 Dollar to Pool O'Muckhart) (Temporary Speed Restriction) Order 2021" and notwithstanding the date hereof, shall come into operation at 0800 hours on Monday 19th July 2021 and will remain in operation for a period of 8 months.
- 2. The effect of this Order shall be to reduce the speed to 40mph:-

During the period from 0800 hours on Monday 19th July 2021 and will remain in operation for a period of 8 months, on the section of roads described in Schedule. The temporary speed restriction is necessary for safety during the removal of timber by Tilhill. The restriction will only have effect in relation to such part or parts of the lengths or road as are indicated by the appropriate traffic signs and during the periods corresponding to those lengths of road specified the Schedule to this Notice.

The Council has made "The Clackmannanshire Council (A91 Dollar to Pool O'Muckhart) (Temporary Speed Restriction) Order 2021, under the Road Traffic Regulation Act 1984 (as amended) on 23rd June 2021: to reduce the speed to 40mph at **A91 Dollar to Pool O'Muckhart** (From a point 300 metres southwest of its junction with Upper Hillfoots Road north eastwards for a distance of 442 metres or thereby). The order runs from 0800 hours on Monday 19th July 2021 for a period of 8 months and is necessary for safety during the removal of timber by Tilhill. The restriction will only effect in relation to such part or parts of the lengths or road as are indicated by the appropriate traffic signs and during the periods corresponding to those lengths of road specified in the Schedule to this Notice.
