



**(A907 CLACKMANNAN ROAD, ALLOA)
(TEMPORARY SPEED RESTRICTION) ORDER 2021**

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restrictions) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

1. This Order may be cited as "The Clackmannanshire Council (A907 Clackmannan Road, Alloa) (Temporary Speed Restriction) Order 2021" and notwithstanding the date hereof, shall come into operation at 0100 hours on Monday 2nd August 2021 and will remain in operation until 2359 hours on Friday 13th August 2021.
2. The effect of this Order shall be to reduce the speed to 10mph:-

During the period from 0100 hours on Monday 2nd August 2021 and will remain in operation until 2359 hours on Friday 13th August 2021, on the section of roads described in Schedule. The temporary speed restriction is necessary during carriageway resurfacing works. The restriction will only effect in relation to such part or parts of the lengths of road as are indicated by the appropriate traffic signs and during the periods corresponding to those lengths or road specified in the Schedule to this Notice.

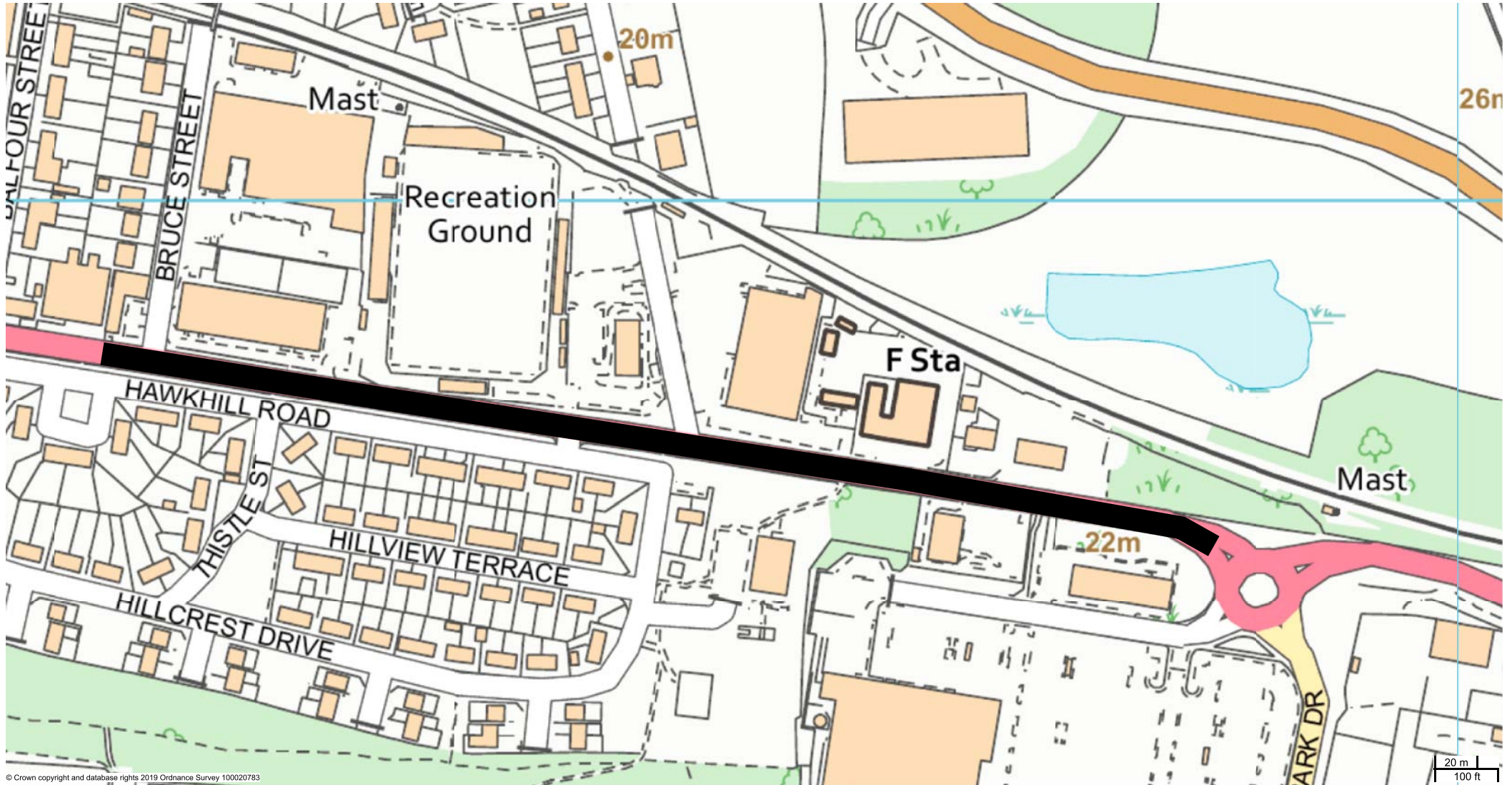
