



**(SCHOOL ROAD, TULLIBODY)
(TEMPORARY PROHIBITION OF DRIVING, PARKING AND LOADING) ORDER 2021**

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restriction) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

1. This Order may be cited as "The Clackmannanshire Council (School Road, Tullibody) (Temporary Prohibition of Driving, Parking and Loading) Order 2021" and notwithstanding the date hereof, the Schedule shall come into operation at 0800 hours on Monday 2nd August 2021 and will remain in operation for a period of 2 weeks.
2. The effect of this Order is that there will be no driving, parking or loading at any time during:

The period from 0800 hours on Monday 2nd August 2021 for a period of 2 weeks, on the section of roads described in Schedule. The temporary prohibition of driving, parking and loading is necessary for final surfacing to go in place. Access to Lychgate Road will be via a traffic light system.

The Council has made "The Clackmannanshire Council (School Road Tullibody) (Temporary Prohibition of Driving, Parking and Loading) Order 2021, under the Road Traffic Regulation Act 1984 (as amended) on 15th July 2021: where there will be a temporary prohibition of driving, parking and loading at **School Road, Tullibody** (From its junction with Lychgate Road northwards until its junction with Ochil Street, a distance of 290 metres or thereby. Diversions: Via Main Street, Stirling Road, A907, Park Terrace and vice versa. Via Abercromby Place, Manor Crescent, Delph Road, Main Street and vice versa. The order runs from 0800 hours on Monday 2nd August 2021 for a period of 2 weeks. The works are necessary for final surfacing to go in place. 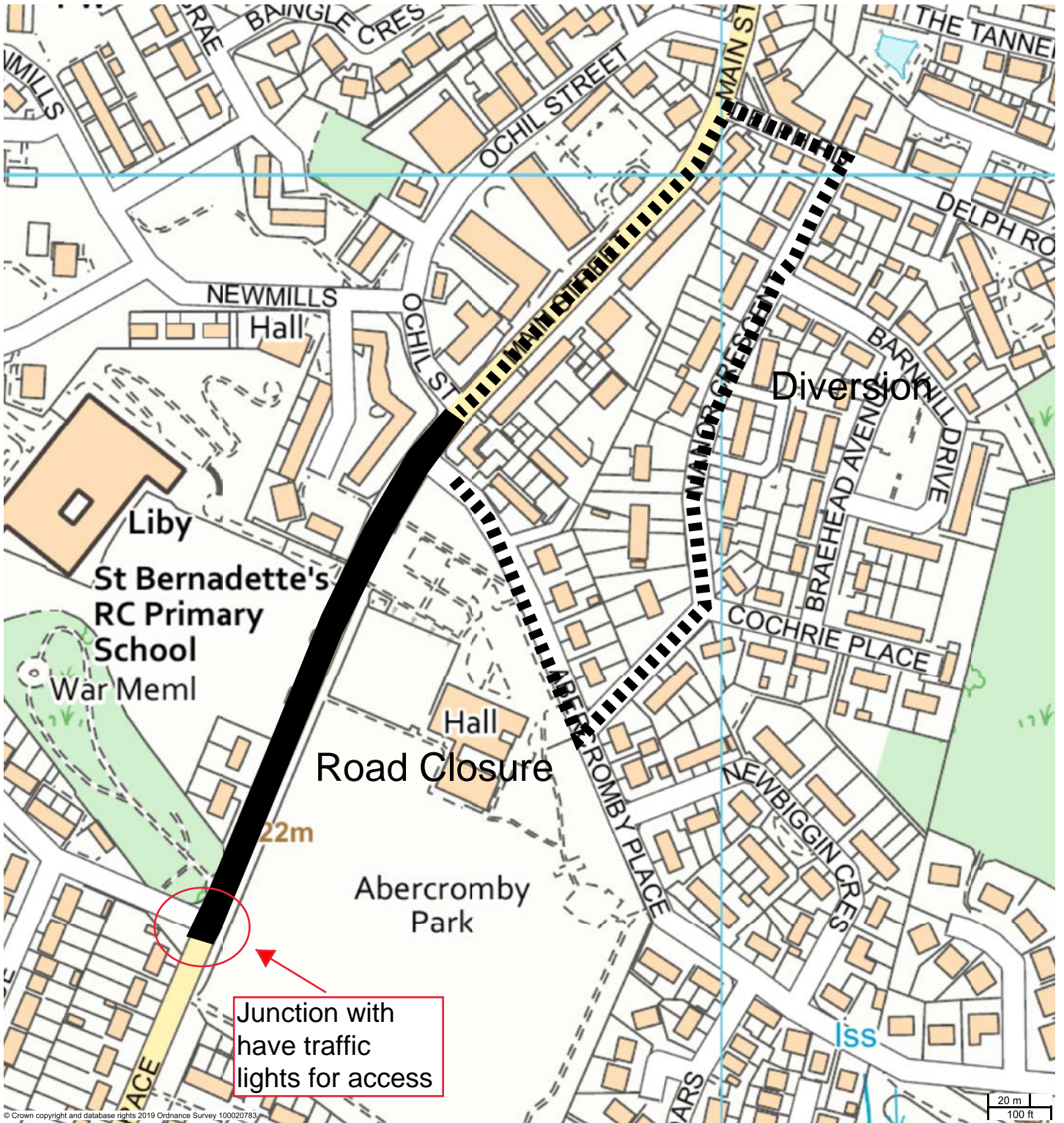
