



**(GEORGE STREET AND BROOKFIELD PLACE, ALVA)
(TEMPORARY NO PARKING RESTRICTION) ORDER 2021**

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restrictions) Act 1991 and of all other powers enabling them in that behalf hereby make the following Order.

1. This Order may be cited as "The Clackmannanshire Council (George Street, Alva) (Temporary No Parking Restriction) Order 2021" and notwithstanding the date hereof shall come into operation at 0930 hours on Wednesday 18 August 2021 and will remain in operation for a period of 3 days..
2. The effect of this Order shall be to suspend parking during:-
The period from 0930 hours on Wednesday 18 August 2021 for a period of 3 days, on the section described in the Schedule attached. The temporary parking suspension is necessary for traffic management control during blockage clearance on a BT duct line.

The Clackmannanshire Council (George Street and Brookfield Place, Alva) (Temporary No Parking Restriction) Order 2021

The Council has made "The Clackmannanshire Council (George Street and Brookfield Place, Alva) (Temporary No Parking Restriction) Order 2021", under the Road Traffic Regulation Act 1984 (as amended) on 4 August 2021: to suspend parking at **Erskine Street, Alva** – Both sides - from a point 80 metres west of its junction with Brookfield Place, eastwards for a distance of 176 metres or thereby; and **Brookfield Place, Alva** – both sides – from its junction with George Street, southwards for a distance of 50 metres or thereby. The order runs from 0930 hours on Wednesday 18 August 2021 for a period of 3 days and is necessary for traffic management control during blockage clearance on a BT duct line.

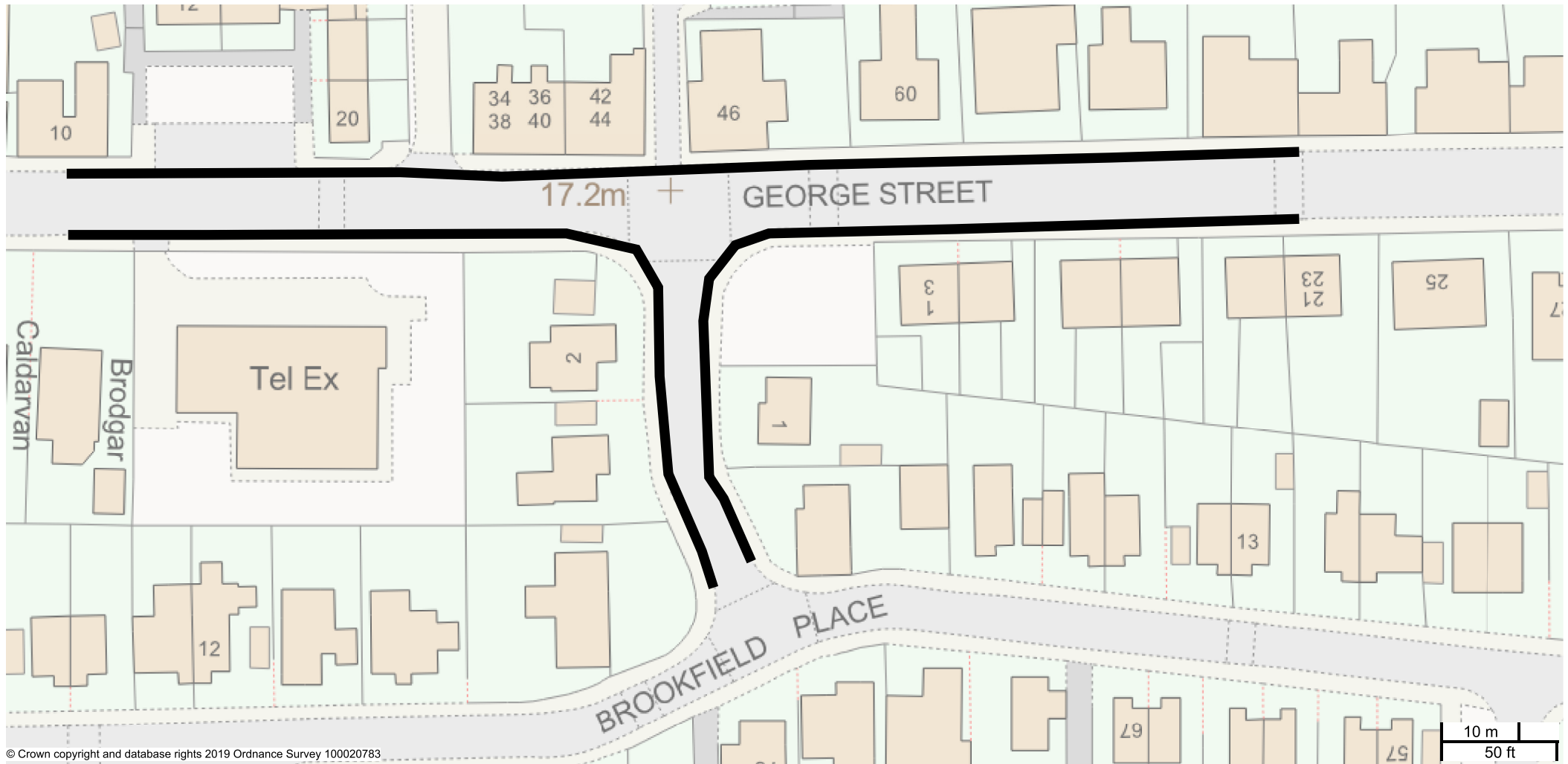
