



**(CRAIGBANK, SAUCHIE)
(TEMPORARY ROAD CLOSURE) ORDER 2021**

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restrictions) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

1. This Order may be cited as "The Clackmannanshire Council (Craigbank, Sauchie) (Temporary Road Closure) Order 2021" and notwithstanding the date hereof, Schedule shall come into operation at 0700 hours on Wednesday 8th September 2021 and will remain in operation until 1700 hours on Sunday 12th September 2021.
2. The effect of this Order shall be to close to vehicles:-

During the period from 0700 hours on Wednesday 8th September 2021 until 1700 hours on Sunday 12th September 2021, on the section of roads described in Schedule. The temporary closure is necessary for excavation for a pillar upgrade and will be digging out onto the middle of the road with a load of spoil.

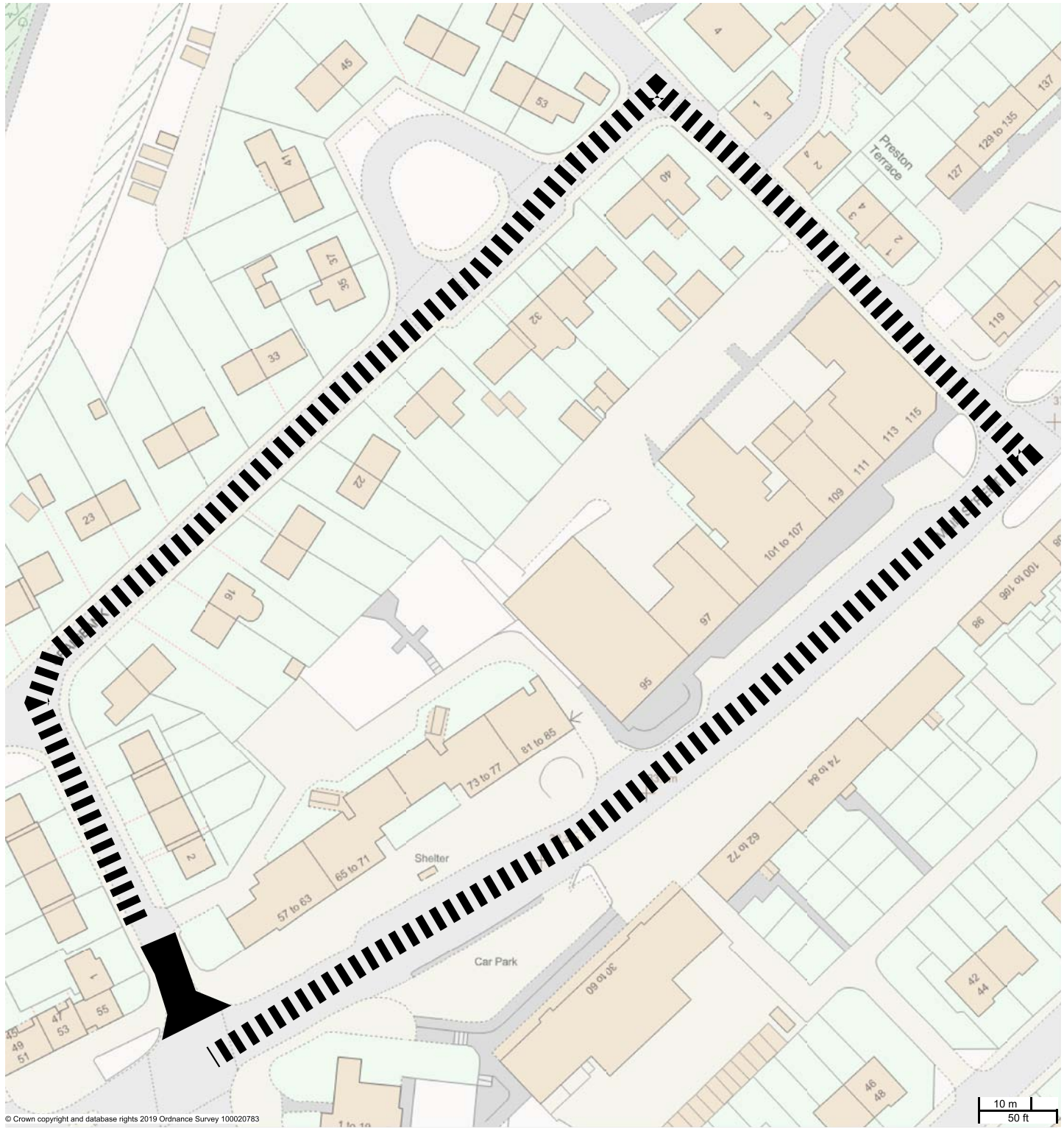
