



**(VARIOUS STREETS, ALLOA
(TEMPORARY ROLLING ROAD CLOSURE) ORDER 2021**

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restrictions) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

1. This Order may be cited as "The Clackmannanshire Council (Various Streets, Alloa) (Temporary Rolling Road Closure) Order 2021" and notwithstanding the date hereof, Schedule shall come into operation at 1100 hours on Saturday 11th September 2021 and will remain in operation until 1145 hours on that day.
2. The effect of this Order shall be to close to vehicles:-

During the period from 1100 hours until 1145 hours on Saturday 11th September 2021, on the section of roads described in Schedule. The temporary closure is required to facilitate a procession for the Kenneth Aitken Memorial District Lodge Parade. The rolling road closure will assist Police Scotland in their duties.

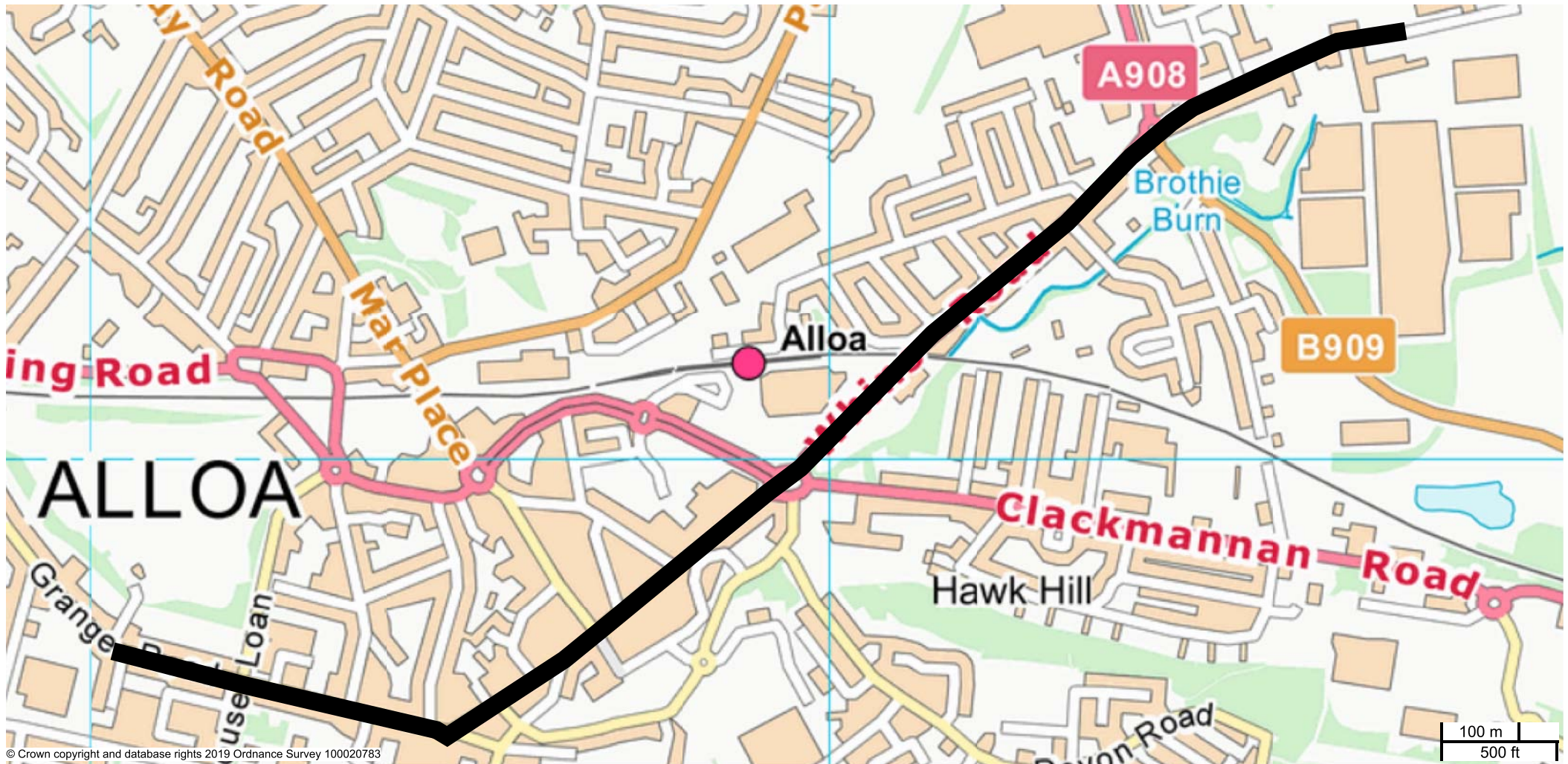
