1. This Order may be cited as "The Clackmannanshire Council (East Stirling Street, Alva) (Temporary Footway Closure) Order 2021" and notwithstanding the date hereof shall come into operation at 0000 hours on Monday 20<sup>th</sup> September 2021 and will remain in operation until 1700 hours on Wednesday 29<sup>th</sup> September 2021.
2. The effect of this Order shall be to close to pedestrians:-  
The period from 0000 hours on Monday 20<sup>th</sup> September 2021 until 1700 hours on Wednesday 29<sup>th</sup> September 2021, on the section described in the Schedule attached. The temporary footway closure is necessary for new footway construction.

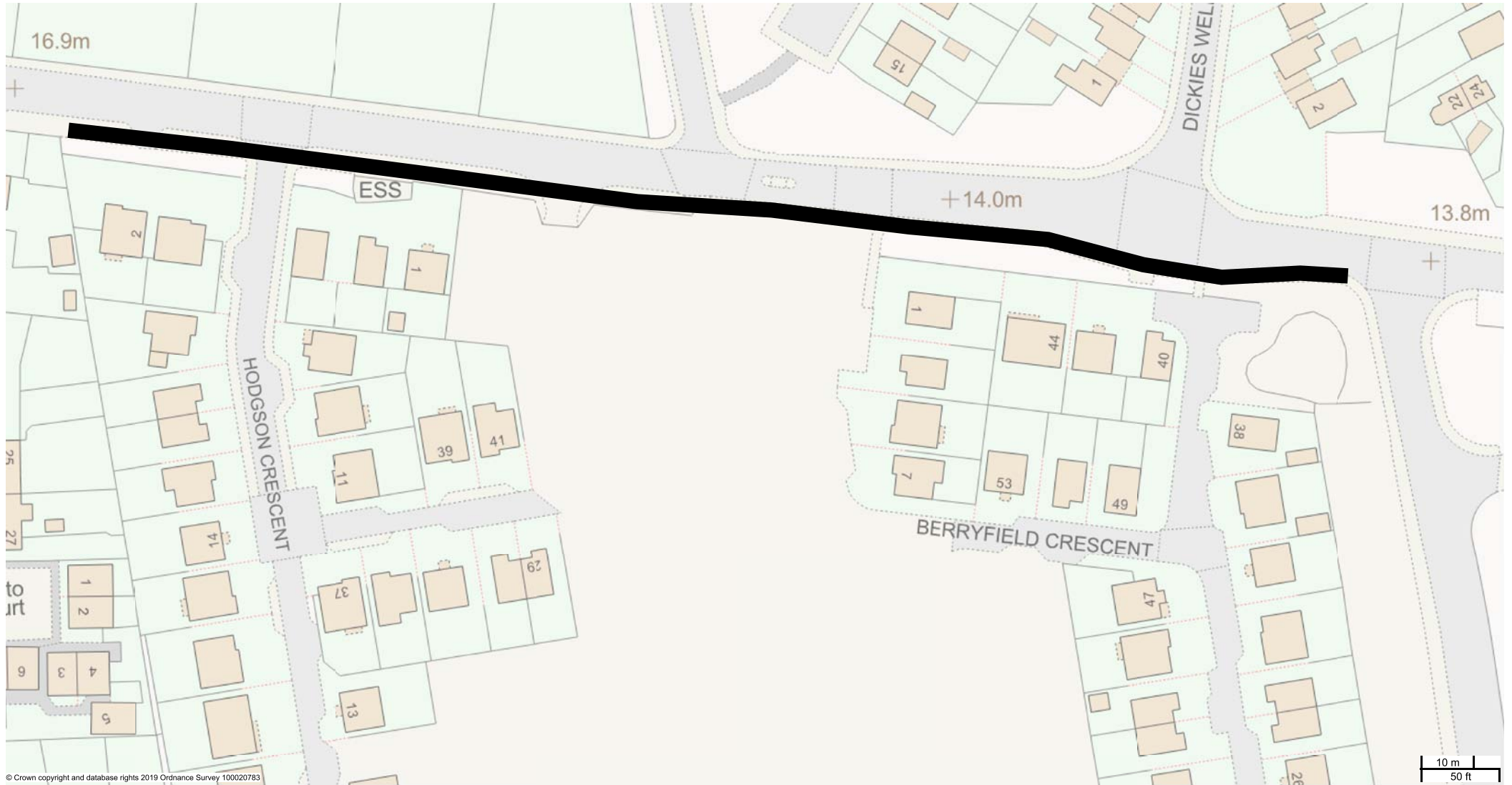
