



**(COBDEN STREET, ALVA)
(TEMPORARY PROHIBITION OF DRIVING, PARKING AND LOADING) ORDER 2021**

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restriction) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

1. This Order may be cited as "The Clackmannanshire Council (Cobden Street, Alva) (Temporary Prohibition of Driving, Parking and Loading) Order 2021" and notwithstanding the date hereof, the Schedule shall come into operation at 0800 hours on Monday 27th September 2021 and will remain in operation until 1800 hours on Wednesday 29th September 2021.
2. The effect of this Order is that there will be no driving, parking or loading at any time during:

The period from 0800 hours on Monday 27th September 2021 until 1800 hours on Wednesday 29th September 2021, on the section of roads described in Schedule. The temporary prohibition of driving, parking and loading is necessary to create a safe working area to allow KN Circet to carry out essential blockage clearance works on behalf of Openreach.

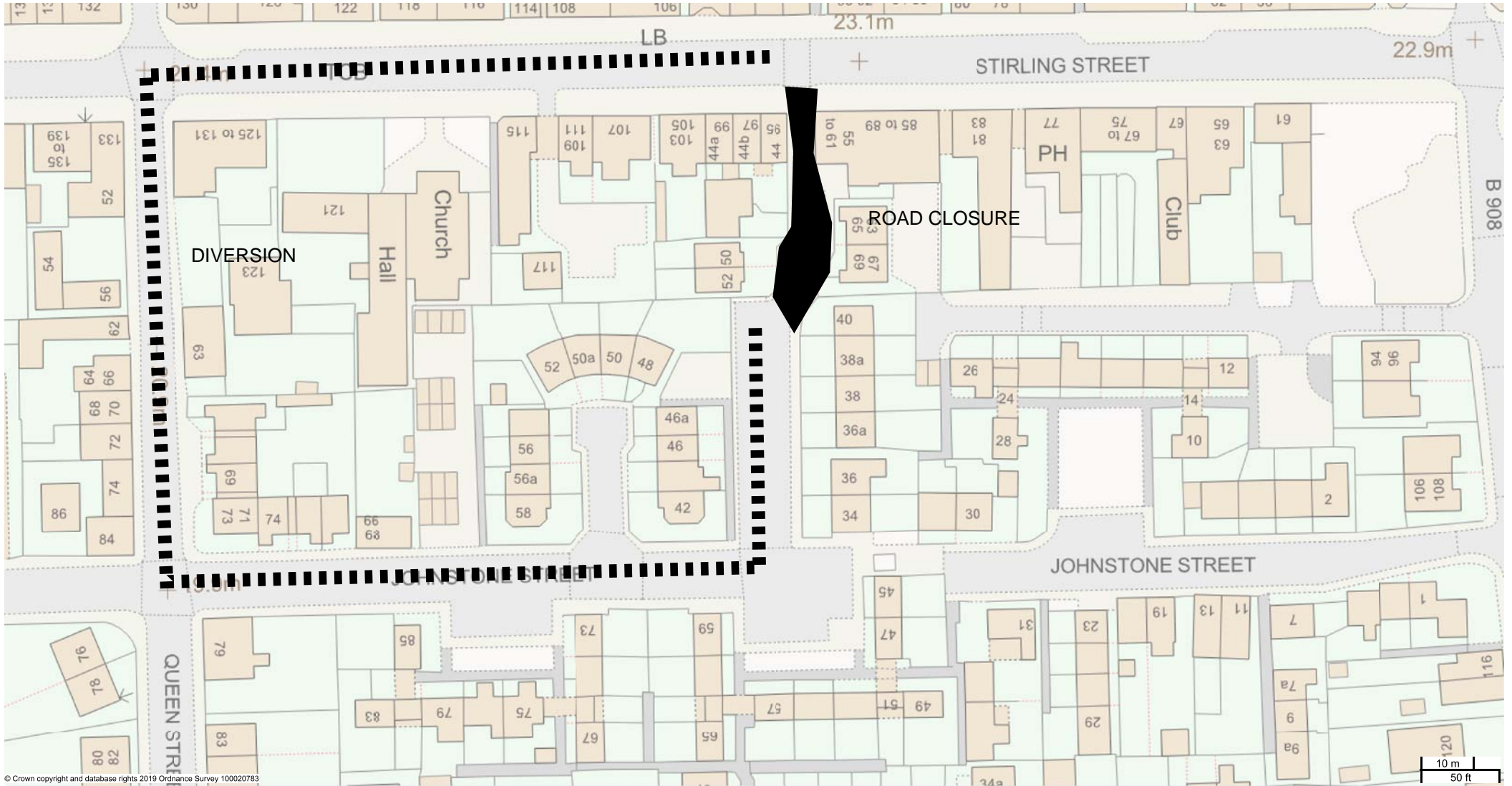
