



**(BANK STREET, ALLOA)
(TEMPORARY REVERSAL OF ONE WAY) ORDER 2021**

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restrictions) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

1. This Order may be cited as "The Clackmannanshire Council (Bank Street, Alloa) (Temporary Reversal of One Way) Order 2021" and notwithstanding the date hereof shall come into operation at 0800 hours on Monday 11th October 2021 and will remain in operation for a period of one week.
2. The effect of this Order shall be reversal one way traffic during:-

During the period from 0800 hours on Monday 11th October 2021 for a period of one week, on the section of roads described in Schedule. The temporary reversal of one way is necessary during the works further down Bank Street.

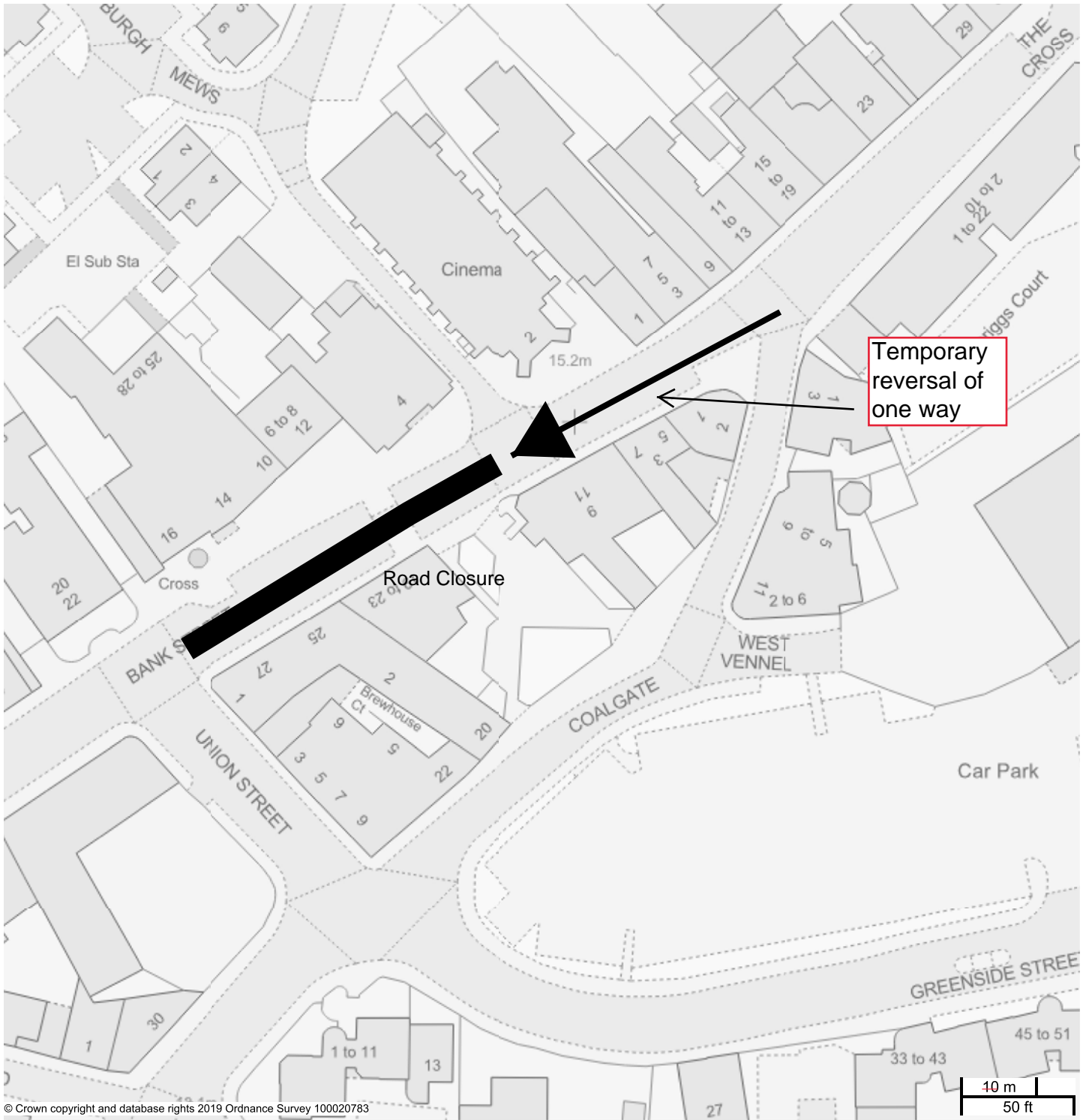
