



**(MAIN STREET, CLACKMANNAN)
(TEMPORARY PROHIBITION OF DRIVING, PARKING AND LOADING) ORDER 2021**

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restriction) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

1. This Order may be cited as "The Clackmannanshire Council (Main Street, Clackmannan) (Temporary Prohibition of Driving, Parking and Loading) Order 2021" and notwithstanding the date hereof, the Schedule shall come into operation at 1530 hours on Sunday 28th November 2021 and will remain in operation until 1900 on that day.
2. The effect of this Order is that there will be no driving, parking or loading at any time during:

The period from 1530 hours until 1900 hours on Sunday 28th October 2021, on the section of roads described in Schedule. The temporary prohibition of driving, parking and loading is required to facilitate Light Up Clackmannan event.

The Council has made "The Clackmannanshire Council (Main Street, Clackmannan) (Temporary Prohibition of Driving, Parking and Loading) Order 2021, under the Road Traffic Regulation Act 1984 (as amended) on 28th October 2021: where there will be a temporary prohibition of driving, parking and loading at **Main Street, Clackmannan** (from its junction with Kirk Wynd eastwards until its junction with Castle Street, a distance of 200 metres or thereby. Alternative Route: Via Kirk Wynd, Alloa Road, Cattlemarket and vice versa. The order runs from 1530 hours until 1900 hours on Sunday 28th November 2021.
