The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restrictions) Act 1991 and of all other powers enabling them in that behalf hereby make the following Order.

1. This Order may be cited as "The Clackmannanshire Council (Castle Street, Alloa) (Temporary Footway Closure) Order 2021" and notwithstanding the date hereof shall come into operation at 0800 hours on Monday 22nd November 2021 and will remain in operation until 1600 hours on Friday 26th November 2021.
2. The effect of this Order shall be to close to pedestrians:-
The period from 0800 hours on Monday 22nd November 2021 until 1600 hours on Friday 26th November 2021, on the section described in the Schedule attached. The temporary footway closure is necessary for construction of new bellmouth access for new car park for OI Glass.

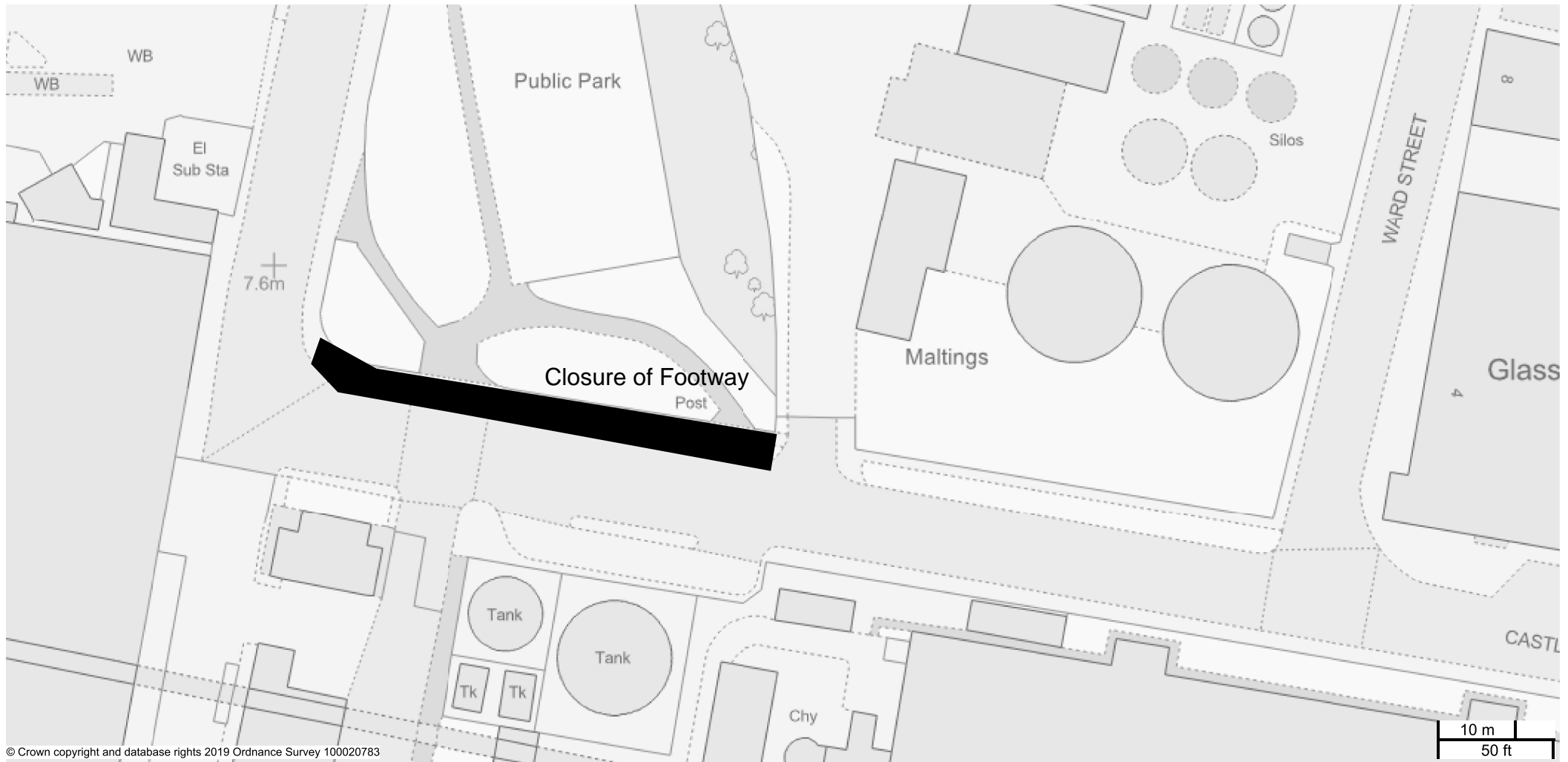
