

(ERSKINE STREET, ALLOA) (TEMPORARY PROHIBITION OF DRIVING, PARKING AND LOADING) ORDER 2021

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restriction) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

- 1. This Order may be cited as "The Clackmannanshire Council (Erskine Street, Alloa) (Temporary Prohibition of Driving, Parking and Loading) Order 2021" and notwithstanding the date hereof, the Schedule shall come into operation at 0800 hours on Monday 6th December 2021 and will remain in operation until 1800 on Wednesday 8th December 2021.
- 2. The effect of this Order is that there will be no driving, parking or loading at any time during:

The period from 0800 hours on Monday 6th December 2021 until 1800 hours on Wednesday 8th December 2021, on the section of roads described in Schedule. The temporary prohibition of driving, parking and loading is required to create a safe working area to allow CJT to carry out essential duct overlay works on behalf of Openreach


