The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restriction) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

1. This Order may be cited as "The Clackmannanshire Council (Church Street, Alloa) (Temporary Prohibition of Parking and Loading) Order 2021" and notwithstanding the date hereof, the Schedule shall come into operation at 0930 hours on Tuesday 21<sup>st</sup> December 2021 and will remain in operation until 1530 on that day.
2. The effect of this Order is that there will be no parking or loading at any time during:

The period from 0930 hours until 1530 hours on Tuesday 21<sup>st</sup> December 2021, on the section of roads described in Schedule. The temporary prohibition of parking and loading is required for Scottish Water iron repairs

The Council has made "The Clackmannanshire Council (Church Street, Alloa) (Temporary Prohibition of Parking and Loading) Order 2021, under the Road Traffic Regulation Act 1984 (as amended) on 24<sup>th</sup> November 2021: where there will be a temporary prohibition of parking and loading at **Church Street, Alloa** (Both Sides - from a point 30 metres or thereby south of its junction with Glebe Terrace southwards for a distance of 65 metres or thereby). The order runs from 0930 hours until 1530 hours on Tuesday 21<sup>st</sup> December 2021. The works are required for Scottish Water iron repairs.

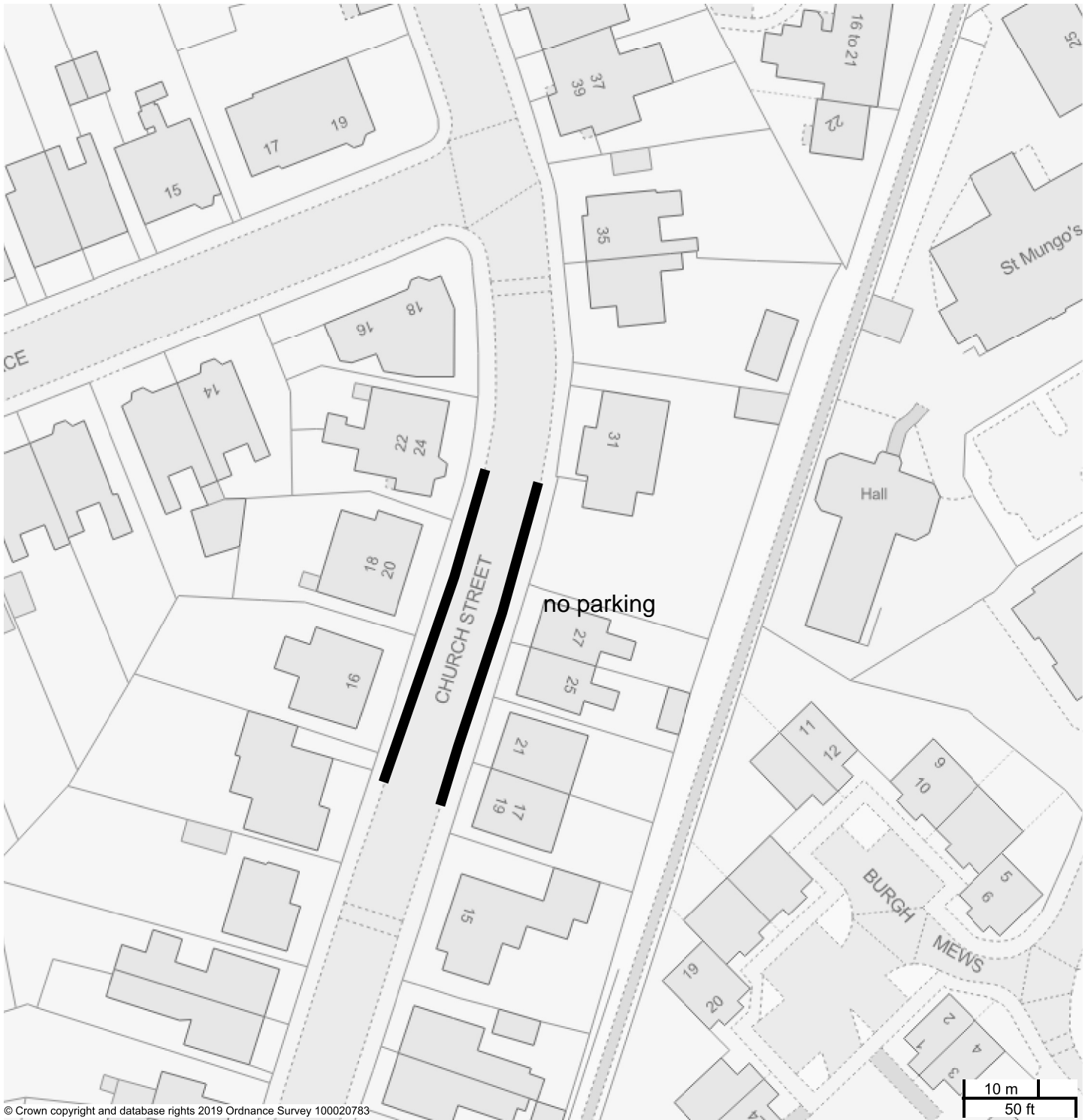
