



**(VARIOUS STREETS, ALVA)  
(TEMPORARY PROHIBITION OF PARKING AND LOADING) ORDER 2022**

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restriction) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

1. This Order may be cited as "The Clackmannanshire Council (Various Streets, Alva) (Temporary Prohibition of Parking and Loading) Order 2022" and notwithstanding the date hereof, the Schedule shall come into operation at 0800 hours on Monday 24<sup>th</sup> January 2022 and will remain in operation until 1700 hours on Wednesday 26<sup>th</sup> January 2022.
2. The effect of this Order is that there will be no parking or loading at any time during:

The period from 0800 hours on Monday 24<sup>th</sup> January 2022 until 1700 hours on Wednesday 26<sup>th</sup> January 2022, on the section of roads described in Schedule. The temporary prohibition of parking and loading is required for installation of new ducts.

## **The Clackmannanshire Council (Various Streets, Alva) (Temporary Prohibition of Parking and Loading) Order 2022**

The Council has made "The Clackmannanshire Council (Various Streets, Alva) (Temporary Prohibition of Parking and Loading) Order 2022, under the Road Traffic Regulation Act 1984 (as amended) on 22<sup>nd</sup> December 2021: where there will be a temporary prohibition of parking and loading at **Ochil Street, Alva** (Both Sides – from its junction with Brook Street eastwards for a distance of 120 metres or thereby); **Braehead, Alva** (Both Sides - from its junction with Ochil Road northwards for a distance of 40 metres or thereby). The order runs from 0800 hours on Monday 24<sup>th</sup> January 2022 until 1700 hours on Wednesday 26<sup>th</sup> January 2022. The works are required for installation of new ducts. 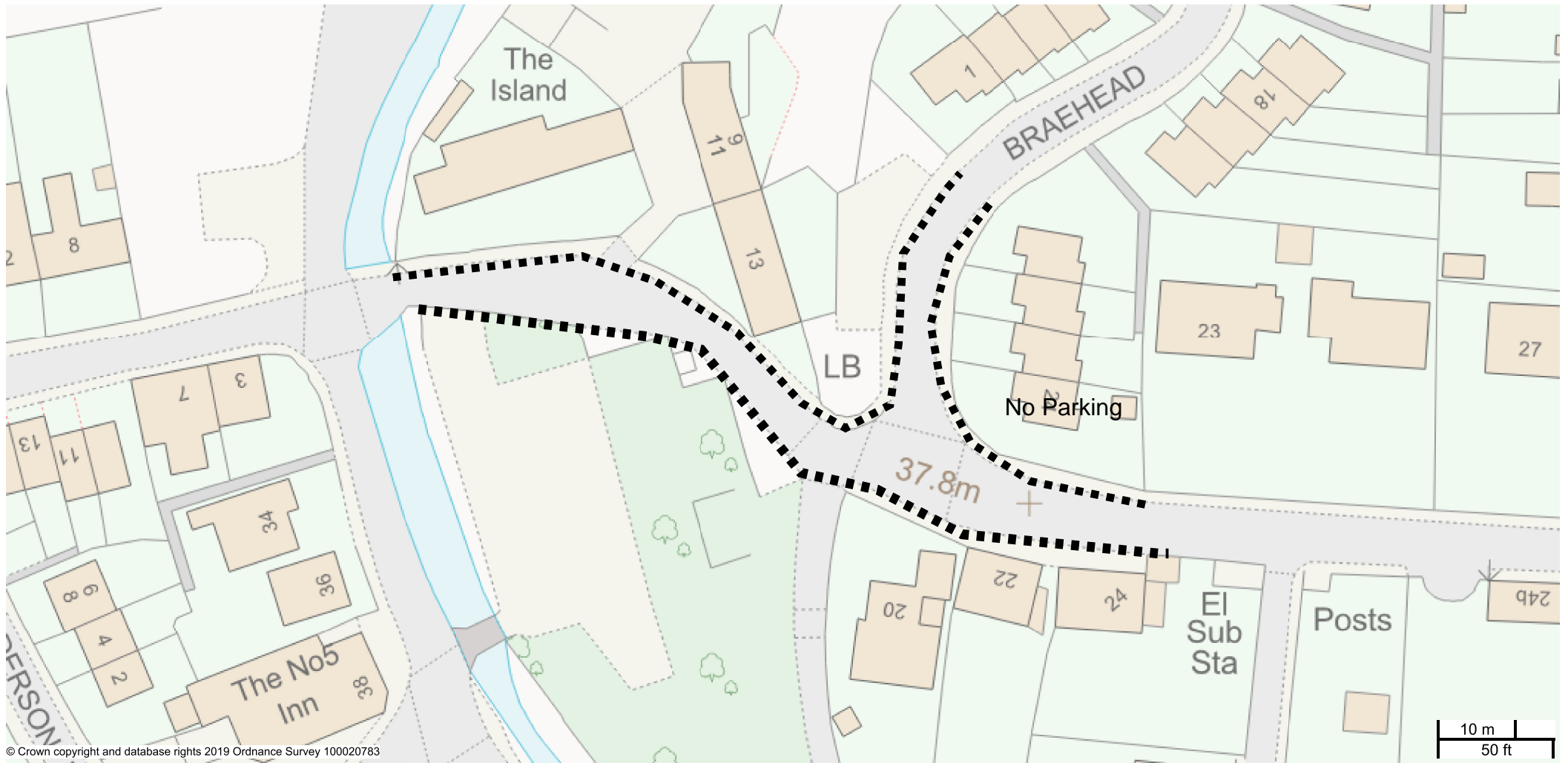
