

### (THE ORCHARD, TULLIBODY) (STOPPING-UP) ORDER 2022

The Clackmannanshire Council in exercise of the powers conferred on them by Section 68(1) (a) of the Roads (Scotland) Act 1984, and of all other powers enabling them in that behalf, hereby make the following Order:-

- This Order may be cited as "The Clackmannanshire Council (The Orchard, Tullibody)
   (Stopping-Up) Order 2022 and shall come into operation on 15<sup>th</sup> April 2022.
- 2. The effect of this Order shall be to stop-up the section of road as detailed in the schedule hereto as it is required for increased safety for pedestrians accessing Tullibody South Campus and to stop through traffic on The Orchard as it is no longer used by a bus service. The road will be removed from the list of adopted roads.
- 3. Where there is, immediately before the date on which the said road is stopped-up under this Order, any apparatus belonging to any statutory undertakers under, in, on, over, along or across this road for the purpose of carrying on their undertaking, the said statutory undertakers shall after the commencement of this Order continue to have all rights in respect of the said apparatus as they had immediately before that date.

Alternative Route: Via The Orchard, Carseview, Newmills, The Orchard. Clackmannanshire Council has made an Order under Section 68(1) (a) of the Roads (Scotland) Act 1984 on 23 June 2020, which will be to stop-up the section of road as detailed in the Schedule hereto for increased safety for pedestrians accessing Tullibody South Campus and to stop through traffic on The Orchard as it is no longer used by a bus service. The road will be removed from the list of adopted roads.
