



**(VARIOUS STREETS, TILlicOUNTRY)  
(TEMPORARY PROHIBITION OF PARKING AND LOADING) ORDER 2022**

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restriction) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

1. This Order may be cited as "The Clackmannanshire Council (Various Streets, Tillicoultry) (Temporary Prohibition of Parking and Loading) Order 2022" and notwithstanding the date hereof, the Schedule shall come into operation at 0930 hours on Friday 11<sup>th</sup> February 2022 and will remain in operation until 1530 hours on that day.
2. The effect of this Order is that there will be no parking or loading at any time during:

The period from 0930 hours until 1530 hours on Friday 11<sup>th</sup> February 2022, on the section of roads described in Schedule. The temporary prohibition of parking and loading is required for Scottish Water ironwork repairs.

## **The Clackmannanshire Council (Various Streets, Tillicoultry) (Temporary Prohibition of Parking and Loading) Order 2022**

The Council has made "The Clackmannanshire Council (Various Streets, Tillicoultry) (Temporary Prohibition of Parking and Loading) Order 2022, under the Road Traffic Regulation Act 1984 (as amended) on 27<sup>th</sup> January 2022: where there will be a temporary prohibition of parking and loading at **High Street, Tillicoultry** (Both Sides – from a point 25 metres or thereby west of its junction with Institution Place eastwards for a distance of 125 metres or thereby); **Stirling Street, Tillicoultry** (Both Sides – from its junction with A91 High Street northwards for a distance of 45 metres or thereby). The order runs from 0930 hours until 1530 hours on Friday 11<sup>th</sup> February 2022. The works are required for Scottish Water ironwork repairs. 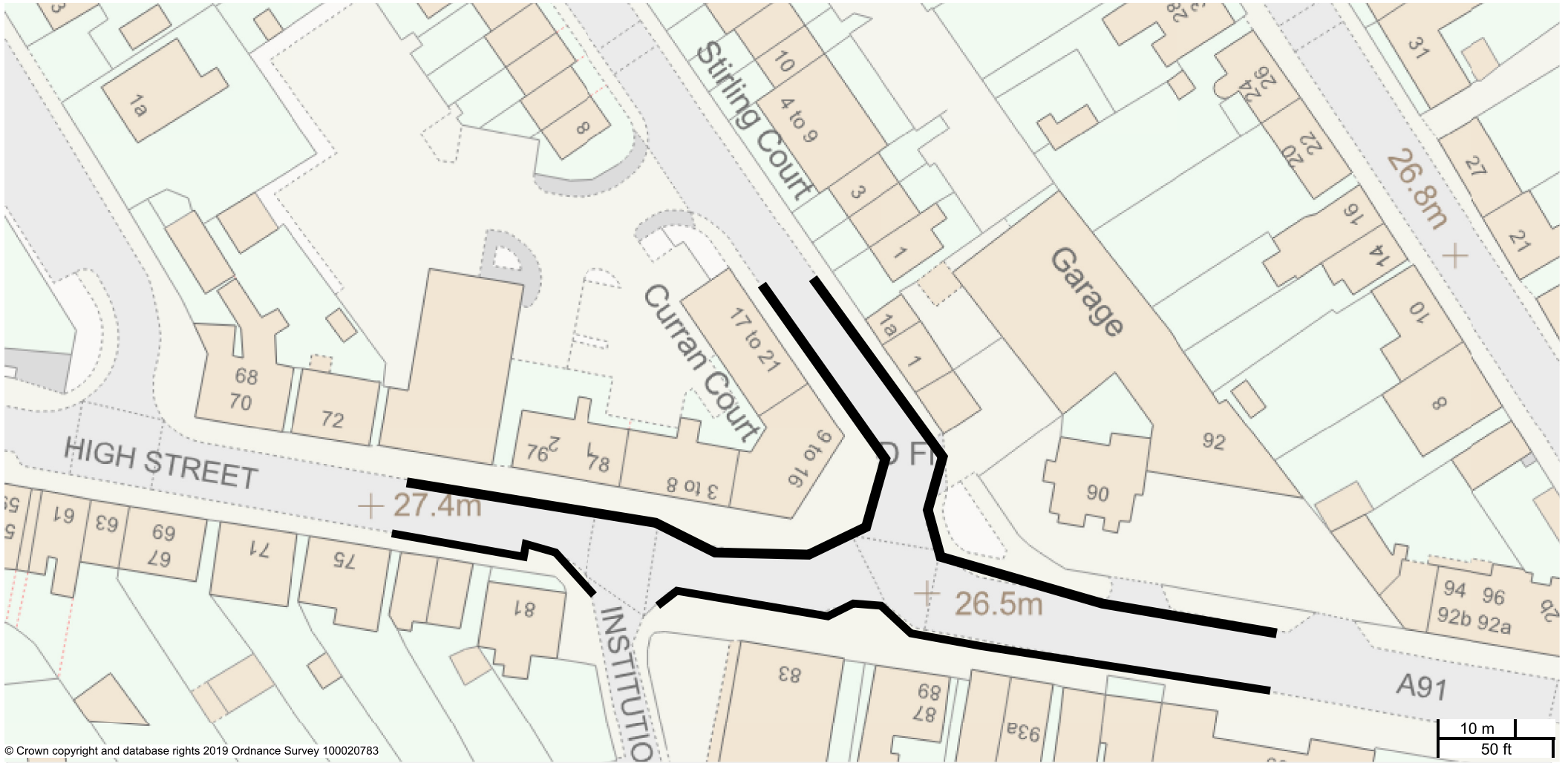
