



**(PRIMROSE STREET, ALLOA)

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restriction) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

1. This Order may be cited as "The Clackmannanshire Council (Primrose Street, Alloa) (Temporary No Waiting or Loading Restriction) Order 2022" and notwithstanding the date hereof, Schedule shall come into operation at 0800 hours on Monday 14th March 2022 and will remain in operation until 1800 hours on Monday 15th August 2022.
2. The effect of this Order shall be that there will be no waiting at any time during:-

The period from 0800 hours on Monday 14th March 2002 until 1800 hours on Monday 15th August 2022, on the section of roads described in Schedule. The temporary no waiting or loading is required to carry out works to new footpaths and disabled parking bays within the development site.
