



**(HIGH STREET, ALLOA)
(TEMPORARY PROHIBITION OF PARKING AND LOADING) ORDER 2022**

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restriction) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

1. This Order may be cited as "The Clackmannanshire Council (High Street, Alloa) (Temporary Prohibition of Parking and Loading) Order 2022" and notwithstanding the date hereof, the Schedule shall come into operation at 0800 hours on Monday 7th March 2022 and will remain in operation until 2359 hours on Friday 11th March 2022.
2. The effect of this Order is that there will be no parking or loading at any time during:

The period from 0800 hours on Monday 7th March 2022 until 2359 hours on Friday 11th March 2022, on the section of roads described in Schedule. The temporary prohibition of parking and loading is required to carry out a permanent disconnection.

The order runs from 0800 hours on Monday 7th March 2022 until 2359 hours on Friday 11th March 2022. The works are required to carry out a permanent disconnection.
