



**(SMITHFIELD LOAN, ALLOA)
(TEMPORARY PROHIBITION OF DRIVING, PARKING AND LOADING) ORDER 2022**

The Clackmannanshire Council, in exercise of the powers conferred on them by Section 14 of the Road Traffic Regulation Act 1984 as amended by the Road Traffic (Temporary Restriction) Act 1991 and of all other powers enabling them in that behalf, hereby make the following Order.

1. This Order may be cited as "The Clackmannanshire Council (Smithfield Loan, Alloa) (Temporary Prohibition of Driving, Parking and Loading) Order 2022" and notwithstanding the date hereof, the Schedule shall come into operation at 0830 hours on Tuesday 28th March 2022 and will remain in operation until 1530 hours on Tuesday 29th March 2022.
2. The effect of this Order is that there will be no driving, parking or loading at any time during:

The period from 0830 hours on Monday 28th March 2022 until 1530 hours on Tuesday 29th March 2022, on the section of roads described in Schedule. The temporary prohibition of driving, parking and loading is required to replace missing/damaged speed humps.

The Council has made "The Clackmannanshire Council (Smithfield Loan, Alloa) (Temporary Prohibition of Driving, Parking and Loading) Order 2022, under the Road Traffic Regulation Act 1984 (as amended) on 3rd March 2022: where there will be a temporary prohibition of driving, parking and loading at **Smithfield Loan, Alloa** (From its junction with Mitchell Crescent westwards until its junction with The Harlands,, a distance of 310 metres or thereby. Diversion: Via Smithfield Loan, A907, Ludgate, Bedford Place, Grange Road, Smithfield Loan and vice versa. The order runs from 0830 hours on Monday 28th March 2022 until 1530 hours on Tuesday 29th March 2022. The works are required to replace missing/damaged speed bumps. 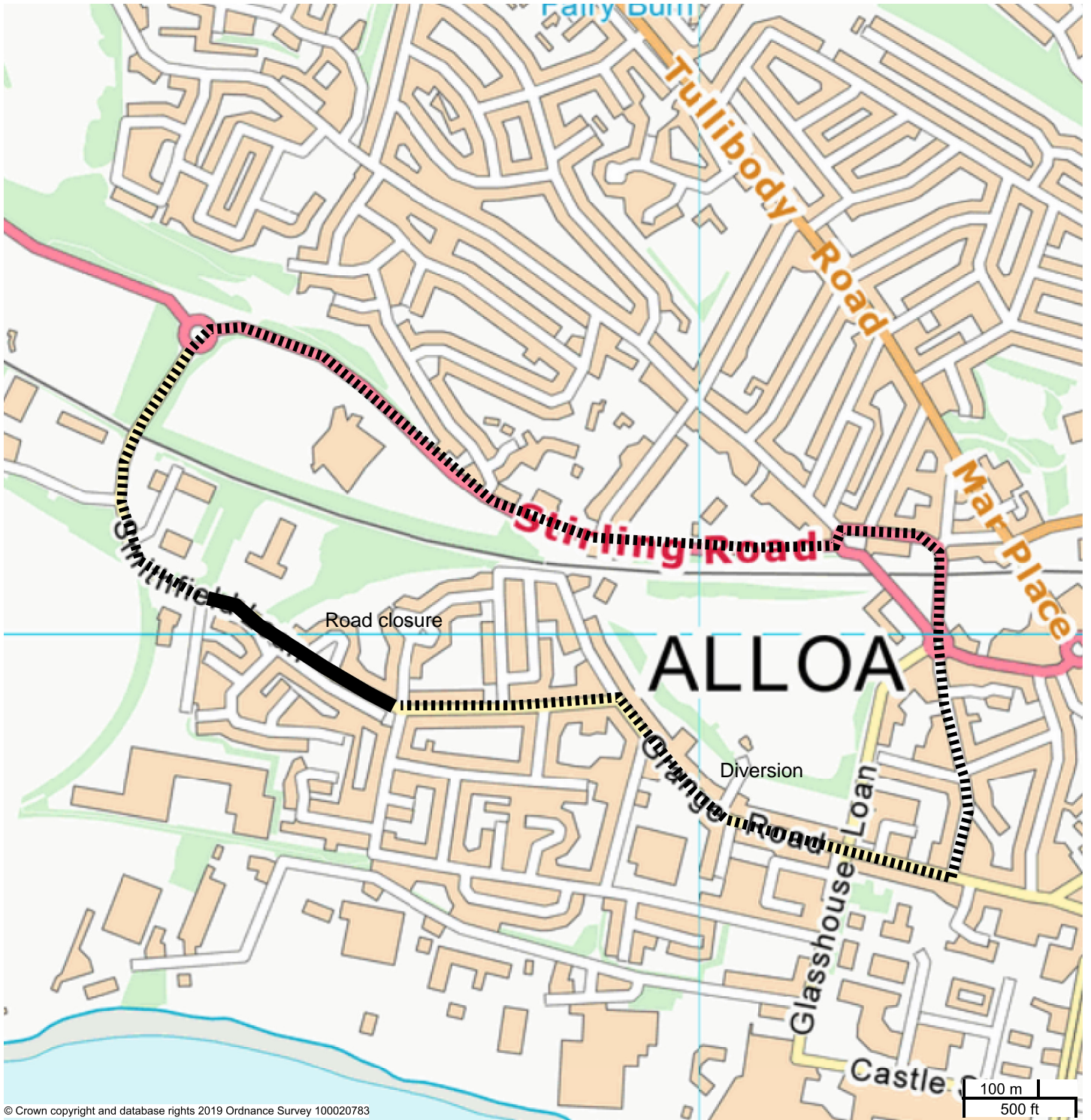
